

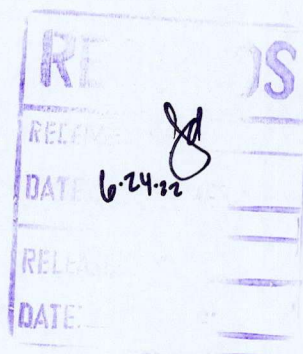
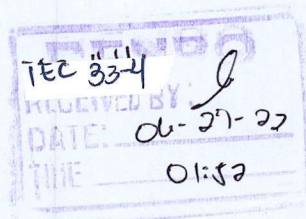

**REPORT OF THE CONDUCTED CONSULTATION MEETING:  
“ONE SAMARICA FOR NATURE”**

As part of the celebration of the DENR's 35<sup>th</sup> Anniversary, this office spearheaded a consultation meeting entitled: One SAMARICA (San Jose, Magsaysay, Rizal, and Calintaan) for Nature that was held on June 21, 2022 at Aroma Family Hotel and Resort Complex, Brgy. San Roque, San Jose, Occidental Mindoro.

This Office invited all the Municipal Environment and Natural Resources Officers (MENROs), representatives from the National Commission on Indigenous Peoples (NCIP), Philippine Ports Authority (PPA), Civil Aviation Authority of the Philippines (CAAP), Coastguard and the Law Enforcement Agencies and Offices within SAMARICA. The meeting was held highlighting the transparency of services and policies, strengthened partnership and intensified environment law enforcement.

The meeting was formally opened with a prayer led by Forest Technician II Herold S. Castro followed by the singing of the Philippine National Anthem. Afterwards, a welcome remarks was delivered by Deputy CENRO- Engr. Nilo P. Salvador expressing his warm gratitude towards the presence of the invited partners. He also emphasized the positive results of the partnership. Immediately after the message, the partners introduced themselves and then proceeded with the meeting proper.


CENRO Efren L. delos Reyes briefly discussed the status of the Philippines' natural resources and its vulnerability to climate change and its impacts as he opened his presentation. Then, he directed to the presentation of CENRO San Jose profile including the total land area and classification per municipality. He also discussed the existing projects of this Office including the status of apprehension within SAMARICA.

CENRO delos Reyes mentioned his gratefulness to the assistance of the different law enforcement agencies in enforcing the ENR laws and policies through its operations and apprehension activities. After the presentation, queries were raised and answered for clarifications.


In the continuation of the meeting, the MENROs presented their proposed and submitted Devolution Transition Plans that are expected to be fully implemented in the year 2024. The discussion on the environmental devolved functions to the LGUs was facilitated in order to realize the possible technical assistance that this Office could provide.

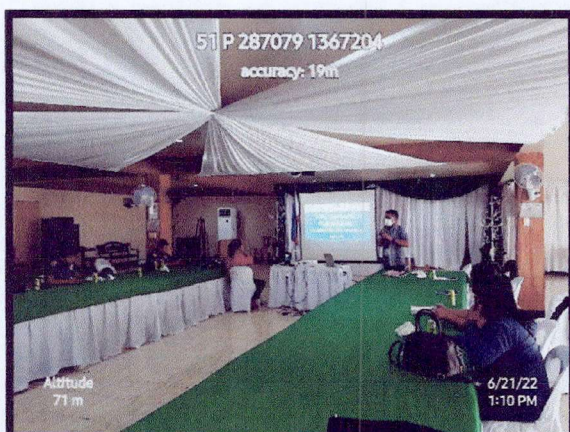
