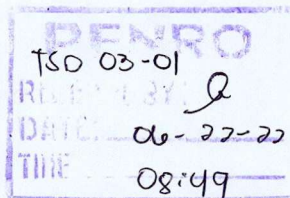
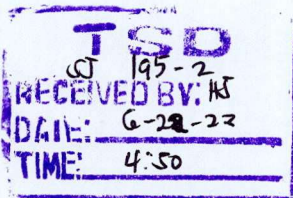



Please be informed that based on our records, there are thirty one (31) confiscated chainsaw by the court subject for disposition.

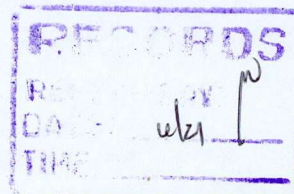

RESOLUTION RESPECTFULLY REQUESTING CENR-OFFICER EFREN L. DELOS REYES, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), SAN JOSE FIELD OFFICE TO DONATE TWO (2) UNITS OF CHAIN SAW TO THE LOCAL GOVERNMENT UNIT OF THE MUNICIPALITY OF MAGSAYSAY, OCCIDENTAL MINDORO"

WHEREAS, every occurrence of typhoon strong wind uproots and destroy buildings, closing roads and thorough fare all along the roads hampering the flow of transport vehicles;

WHEREAS, to normalize the situation the Local Government conducted clearing operation by cutting the uprooted trees and hauling the debris of the destroyed buildings;

WHEREAS, in the clearing operation, cutting of trees endanger houses and other properties and individuals, thus there is a need for the use of chain saw;

WHEREAS, the often occurrence of strong typhoon maybe considered as disastrous phenomenon. As part of the LGU's readiness and preparedness, having two (2) units of Chain Saw shall enhance the safety of our commuters and constituents.

NOW THEREFORE:


