





2. IEC AND ADVOCACY

a. PRODUCTION AND DISTRIBUTION OF IEC MATERIALS

TCP have a target activity for CY 2022 under sub program – Protection and Conservation of Wildlife – 2.0 IEC and advocacy – b. Production and Distribution of IEC materials. Yearly target is Seven Hundred Eighty (780) pieces of IEC materials produced and distributed. For First Quarter of 2022, target is one hundred fifty (150) IEC materials produced and distributed.

For accomplishment of the said target, Five Hundred (500) pieces of IEC Materials were produced and distributed for the 1st Quarter of CY 2022 composed of two hundred fifty (250) brochures and two hundred fifty (250) leaflets. The said IEC materials were distributed during the conduct of the following activities:

March 1, 2022: Conduct *Dalaw-Turo* Activity at Barangay Manoot, Calintaan, Occidental Mindoro; 50 pieces of brochures and 50 pieces of leaflets were distributed.

March 3, 2022: Conduct *Dalaw-Turo* Activity at Barangay Tanyag, Calintaan, Occidental Mindoro; 50 pieces of brochures and 50 pieces of leaflets were distributed.

March 6, 2022: Conduct *Dalaw-Turo* Activity at Barangay Tanyag, Calintaan, Occidental Mindoro; 50 pieces of brochures and 50 pieces of leaflets were distributed.

For 2nd Quarter of CY 2022, 100 shirts were produced in the conduct of Tamraw count 2022. Below is the breakdown of IEC materials produces as of 2nd Quarter 2022.

b. CONDUCT OF DALAW TURO

For CY 2022, TCP have five (5) target activity of Conduct of Dalaw Turo. For First Quarter of CY 2022, target activity is conduct of two (2) dalaw turo, and conduct of three (3) for the Second Quarter. Five (5) *Dalaw Turo* was conducted on First Quarter as accomplishment of the said activity. Reports were submitted on March 20, 2022.

Participants, Date and Venue:

The *Dalaw-Turo* activity was conducted in Occidental and Oriental Mindoro at the following Barangay and participants:

- → March 1, 2022 at Covered Court of Barangay Malpalon, Calintaan, Occidental Mindoro (near Mts. Iglit-Baco Natural Park) participated by fifty (50) Barangay Community composed of twenty-two (22) males and twenty-eight (28) females;
- ↓ March 3, 2022 at Covered Court of Barangay Tanyag, Calintaan, Occidental Mindoro (near Mts. Iglit-Baco Natural Park) participated by forty-eight (48) community members composed of ten (10) males and thirty-eight (38) females;
- ♣ March 6, 2022 at Covered Court of Barangay Aninuan, Puerto Galera, Oriental Mindoro participated by fifty (50) community members composed of thirty-one (31) males and nineteen (19) females;
- ♣ March 7, 2022 at Covered Court of Barangay Baclayan, Puerto Galera, Oriental Mindoro participated by forty-one (41) community members composed of sixteen (16) males and twenty-five (25) females;
