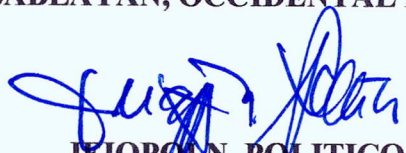
That the **DONEE** shall be responsible for the hauling and documentation of the donated good lumber from the custodian or place stockpiled to the said office.
