Both administrative and criminal cases were filed against Mr. Sonny Zoleta and Eddie Boy Balikadong Banter by the DENR and PNP respectively for violation of Section 77 of PD 705 as amended by RA 7161.

- 4. That transporting undocumented illegal forest products is a crime under Section 77 of PD 705 as amended by RA 7161.
- 5. That in the Administrative hearing conducted on June 3, 2022, the two accused stated that the owner of the apprehended Guijo lumber was unknown to them.
- 6. That the two accused were arrested and brought to the Office of the Provincial Prosecutor at Mamburao, Occidental Mindoro for inquest proceeding.
- 7. That an Information was issued against the two accused on March 21, 2022. The case was docketed as Z-3611.

II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that the accused were caught during the illegal logging operations by the joint force of DENR Enforcement and Monitoring Section, MAPSA Area and Paluan Municipal Police Station. They were caught transporting undocumented forest products which is in violation of Section 77 of PD 705 as amended by RA 7161.

Section 77 clearly states that transporting forest products without proper documents or permit from the proper authority is a violation under PD 705.

III. RECOMMENDATION

Based on the above statement of facts, administrative hearing and criminal case filed, it is hereby recommended that all forest products be forfeited in favor of the government.
