Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated June 9, 2022 relative the above subject.

Per memorandum, the apprehension was made by the personnel of Forest Products Monitoring Station (FPMS) I and members of Philippine National Police - Taytay Station on August 6, 2020 at around 8:15 A.M. The team recovered and apprehended one (1) piece of Apitong Keel or Kasko with equivalent volume of 360 board feet allegedly owned by Mr. Ricardo C. Buefano at Sitio Balite, Barangay Poblacion, Taytay, Palawan.

The apprehended Keel has fair market value of Php21,600.000 and subsequently brought to the area of Forest Products Monitoring Station VI at Barangay Old Guinlo, Taytay, Palawan for safekeeping purposes under the custody of CENRO Property Custodian Norie D. Pineda.

Notices to the public were posted in conspicuous places on August 28, 2020, September 4, 2020 and November 11, 2020 respectively in relation to Section 8, Item No. 3 of DAO 1997-32. However, the subject item was seized for failure to claim by concerned parties despite invitation through public notices posted for three (3) consecutive weeks. Further, investigation was ensued and sent the notice of hearing dated September 25, 2020 to the suspect for October 9, 2020 administrative hearing. It was found out during the hearing that one (1) piece of Apitong Keel or Kasko is abandoned. Thus, the Hearing Officer recommends for the issuance of confiscation order of the said forest product.

We concur with the CENRO recommendation for the issuance of confiscation order.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

#### WHAT

FOR

This is the final report on the administrative adjudication of the one (1) piece of lumber of Apitong species equivalent to three hundred sixty (360) board feet.

#### WHEN

The interception/recovery took place last August 6, 2020 at 8:15 in the morning and the corresponding report was submitted and received in the Office on August 6, 2020 (Annexes A to A<sub>1</sub>) plus the geo-tagged pictures (Annex B), and the Apprehension Receipt (Annex C to C<sub>2</sub>).

#### WHERE

The forest products were recovered in Sitio Balite, Barangay Poblacion, Taytay, Palawan and brought to Protected Area Management Office (PAMO) in Barangay Old Guinlo, Taytay, Palawan.

#### WHO

Both the report and the apprehension receipt alleged Mr. Recardo C. Buefano as the owner of the said item. The operating enforcers were members of the Forest Product Monitoring Station (FPMS) I led by then Team Leader Francis John Vincent G. Sanchez together with the representatives from the Philippine National Police-Taytay station.

### WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

#### HOW

The enforcement officer received information from a concerned citizen informing about the item. The team together with the PNP representatives proceeded to the area and conducted

initial investigation at the property of certain Recardo C. Buefano. Present on the area is the said one (1) 'piece keel or kasko with an equivalent volume of 360 board feet.

## Adjudication procedure

Seizure Order (Annex D to  $D_2$ ) and Seizure Receipt (Annex E) were facilitated on August 28, 2020 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of twenty-one thousand, six hundred (21,600) pesos. Though the report and the apprehension receipt alleged Mr. Buefano, public notices (Pabatid sa Publiko) were also posted consecutively every week on August 28, September 4 and November 11, 2020 (Annexes F to  $F_2$ ). The Certification on the posting of the Pabatid sa Publiko is Annex G. The hearing was then set on October 9, 2020 with notice letters dated September 25, 2020 sent to the respondent (Annexes H to  $H_3$ ).

The examination pushed through as evidenced by the Attendance Sheet (Annex I).

Preliminaries in the hearing include the review of the report, attendance check, house rules, and IEC on forestry laws, especially the forest protection. Responding to the *HO*, *Buefano* to comment on his name spelled as RI as in Ricardo.

Examiner to Apprehending Officer inquired on how they determine that the property belonged to Buefano. FR Sanchez answered back stating that they had a conversation with his sister; that the property belonged to Buefano and that he was a driver in El Nido, Palawan.

Examiner then turned to Buefano, asking if he owns the lumber. Responding to HO, Buefano promptly answer "no"; that someone left the lumber inside his property way back 2015 to his mother; and that he had no idea who's the owner of the lumber since the information was relayed to him via phone call.

Examiner turned to Apprehending Officer asking on the description of the lumber. FR Sanchez replied that the lumber was "luma na" while Buefano seconded that maybe it was already 5 years in the area. FR Sanchez also added that they noticed the area to be "pagawaaan ng bangka" since evidence of used lumber was present, remnants of unfinished constructed Bangka and that according to Buefano's sister they stopped the construction due to lack of budget.

Examiner to Buefano, inquired about his occupation and how he acquired the property. Buefano responded that he is a driver of Mayor Lim of El Nido and he acquired the wayback 1985 and the title was approved on 1996 with the signature of former President Fidel V. Ramos. HO clarified to have titled under his name but Buefano answered that the property was named to his brother Ramon and it was not yet subdivided. HO to Buefano confirmed that the lumber was brought to their property sometime in 2015 and why not made an effort to take the issue to the Barangay. Responding to HO, Buefano answered yes; that someone left the lumber to his mother care but unfortunately his mother passed away 2 years ago; that he lived in El Nido and that he thinks it is okay to put the lumber inside their property. HO then asked him (Buefano) if he had a pumpboat and Buefano readily answered to have none. HO then followed up his inquiry on his comment that the area is somewhat "pagawaan ng Bangka". Buefano replied that maybe it was constructed it there because his brothers engaged in construction of Bangka. HO then commented that before the lumber were left in the area, he was already notified about it and asked if he had a suspect on matter. Again, Buefano insisted that he was notified thru phone call only; that he had no suspect to whom the lumber is; and promised not to allow to put or piled lumber in their area.

Being no issues to tackle, HO then finalized the hearing by commenting that he had doubts on the involvement of Buefano on the matter. The transcript of minutes of the hearing is therefore Annex J to  $J_5$ .

#### Conclusion and recommendation

Though the item was found inside the property of the Buefano, one cannot be directly accused as liable in the said case. The involvement of Mr. Ricardo Buefano is undeniably lacks in merit hence cannot be filed for violation of Section 77 of Presidential Decree 705. On the above foregoing, the undersigned recommends to put Mr. Ricardo Buefano in the watch list of this Office. Further, the item listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus the Hearing Officer also recommended for the issuance of Order of Forfeiture in favor of the Government.

Quick Response Team 1 together with representatives from the Philippine National Police – Taytay Station proceeded to the area and conducted initial an investigation at the property of a certain Recardo C. Buefano. Upon arriving at the said area, we saw one (1) Apitong (Dipterocarpus grandiflorus) keel or *kasko* that has a dimension of 6x24x30 and a volume of three hundred and sixty (360.00) board feet.

The team coordinated with Forest Product Monitoring Station – VI led by FR Ricardo S. Tandoc in apprehending the keel using a *motorized Banca* and brought it to FPMS – VI at Barangay Old Guinlo, Taytay, Palawan for safekeeping.




