

ON THE APPREHENDED RAIN TREE LUMBERS (Samanea saman) WITH A TOTAL VOLUME OF SIX HUNDRED FORTY SEVEN AND 75/100 (647.75) BD. FT. LOCATED IN BRGY. AMATONG,

**ODIONGAN, ROMBLON** 

Respectfully submitting herewith the report regarding the above-cited subject to wit;

#### **FACTS:**

At around 7:30 in the evening, we received a phone call from a concerned citizen regarding the information that there is a transport of forest products/lumbers that originates from Brgy. Amatong, Odiongan, Romblon.

#### **ACTIONS:**

To conduct immediate inspection, verification and investigation on the said subject matter situated in Brgy. Amatong, Odiongan, Romblon and properly coordinated to other Law Enforcement Agencies for security purposes.

#### FIELD FINDINGS/ OBSERVATIONS:

- 1. That on January 05, 2022, the DENR personnel spearheaded by Forester James M. Mendoza immediately conducted inspection and investigation through the instructions of our OIC-TSD Forester Thelmo S. Hernandez together with Odiongan Municipal Police Station (OMPS) represented by PEMS ARNEL M PEDRAGOZA, Romblon Provincial Mobile Force Company (RPMFC) headed by FORCE COMMANDER PLTCOL WINNERIO D PAGUIA JR and from Criminal Investigation and Detection Group (CIDG) also represented by PAT JOHN EDDIEMARK A GARCIA regarding the above-cited subject matter;
- 2. That the Apprehending Officers directly proceeded in the subject area to confirm the information about these activity;
- 3. That based on our ocular inspection and investigation in the area, we've seen and found out the stock pile of lumbers.

- 4. That time, we introduced ourselves as employees of DENR, then asked any legal documents pertaining to the lumbers under the premises of a certain **Mr. Sam Urbano**, resident of Sitio Ligaya, Brgy. Amatong, Odiongan, Romblon (alleged Owner/buyer);
- Upon in-depth investigation, Mr. Urbano said that the lumbers was bought to a certain Mr. Roy Fadera (Seller) and a resident of Brgy. Liwanag, Odiongan, Romblon;
- 6. That Mr. Urbano did not present any legal documents as a proof that the forest products/lumbers is legally transported and delivered within his premises. Hence, the lumbers was subject for apprehension since they violated PD 705 under Sec. 77 as amended by R.A. 7161;
- 7. That before the apprehension of the said lumbers the DENR personnel stated "Miranda Rights" to a certain Mr. Urbano with the assistance of the Odiongan Municipal Police Station, Provincial Mobile Force Company and Criminal Investigation and Detection Group.
- 8. That during inventory, the lumbers was identified as Rain tree with a local name Acacia having a different dimensions with a total volume of Six Hundred Forty Seven and 75/100 bd.ft. (647.75).
- 9. That the lumbers was immediately hauled to the DENR-PENR Office for safekeeping and proper disposition.

#### **RECOMMENDATIONS:**

Considering the above findings and observations, the undersigned recommends the conduct of Administrative Hearing at DENR-PENR Office since they violated section 77 of P.D. 705 as amended by R.A. 7161 in compliance to our existing Environmental Laws, Rules and Regulations. A case must be filed against the violators and the said lumbers be forfeited in favour of the government.
