


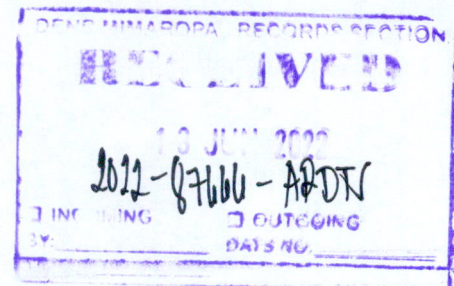
As per the above-mentioned letter, no meeting has been convened as to the final settlement of both parties

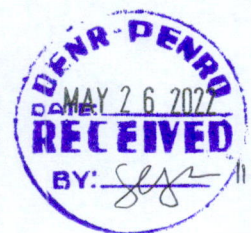

This is in reply to your letter that has been received on May 24, 2022 requesting for the update regarding the planned settlement between the PNP and Philippine Army over lot 507-A and lot 507-B located in Brgy Dapawan, Odiongan, Romblon in relation with the consultative meeting between LGU-Odiongan, PNP PROMIMAROPA and Philippine Army held last June 17, 2021.

In view of this, we would like to inform you that on March 30, 2022 at 1:00pm, a meeting was conducted between the PNP represented by PCOL RAYNOLD A ROSERO, Provincial Director, Romblon PPO, PLTCOL WINNERIO D PAGUIA JR, Force Commander, Romblon PMFC, PMAJ LEDILYN Y AMBONAN, Logistics and Supply Officer, Odiongan LGU represented by Hon. MAYOR TRINA ALEJANDRA F FABIC, ENGR JOHN FELIX FORTU, Geodetic Engineer, Odiongan LGU and Philippine Army represented by LTC ANTHONY C CARO, OIC, AREC, IMCOM, PA, MAJ ELEGIO H BACQUIAL, JR, Group Director, 410, CDC, ARESKOM held at Romblon Provincial Mobile Force Company, Brgy Dapawan, Odiongan, Romblon presided by PCOL RAYNOLD A ROSERO, Provincial Director, Romblon PPO wherein during the said meeting, Mayor Firmalo presented the two (2) proposed subdivision scheme of Lot 507. She pointed out that Lot 507-A with an area of 2,150 square meters will be shared to the Philippine Army while the Lot 507-A-1, Lot 507-B-4-B with an area of 4,558 square meters and Lot 507-B-1-C with an area of 8,292 square meters will become part of the PNP in which all parties agreed on the proposed new subdivision scheme.

Moreover on April 8, 2022 at 10:00am, another meeting was conducted via zoom between the PNP represented by PLTCOL WINLOVE RAMOS, Chief, Regional Legal Service, PCOL RAYNOLD A ROSERO, Provincial Director, Romblon PPO, PLTCOL WINNERIO D PAGUIA JR, Force Commander, Romblon MFC, PMAJ LEDILYN Y AMBONAN, Logistics and Supply Officer, Odiongan LGU represented by Mr. KIM FADERON representative of Hon. MAYOR TRINA ALEJANDRA F FABIC, ENGR JOHN FELIX FORTU, Geodetic Engineer, Odiongan LGU and Philippine Army represented by LTC ANTHONY C CARO, OIC, AREC, IMCOM, PA presided by PBGEN BALTAZAR V RIVERA, Deputy Regional Director for Administration, PRO



Pat Mary Jeraldine M Villanueva led the prayer.

1st presenter was **HON. TRINA ALEJANDRA Q FIRMALO-FABIC** (Municipal Mayor of Odiongan) wherein she presented and discussed the two (2) proposed subdivision scheme of LOT 507 Dapawan, Odiongan, Romblon. She pointed out that LOT 507-A-2 with an area of 12,850 square meters and LOT 507-B-4-A with an area of 2,150

square meters will be shared to the Philippine Army while the LOT 507-A-1, LOT 507-B-4-B with an area of 4,558 square meters and LOT 507-B-1-C with an area of 8,292 square meters will become part of PNP.

OPEN FORUM AND DISCUSSION

During the open forum PCOL RAYNOLD A ROSERO, PD, Romblon PPO acted as the moderator wherein he identified and acknowledged those personalities who attended the meeting.

The Philippine Army Representative headed by MAJ ELEGIO H BACQUIAL, JR and LTC ANTHONY C CARO and PMFC Forcer Commander, PLTCOL WINNERIO D PAGUIA JR all agreed to the newly proposed subdivision scheme and discussion of HON. TRINA ALEJANDRA Q FIRMALO-FABIC about LOT 507-A-2 with an area of 12,850 square meters and LOT 507-B-4-A with an area of 2,150 square meters will be shared to Philippine Army while the LOT 507-A-1, LOT 507-B-4-B with an area of 4,558 square meters and LOT 507-B-1-C with an area of 8,292 square meters will become part of the PNP in addition to the remaining areas of lot 507-A.



All parties agreed with no further comments and suggestions raised.

PCOL RAYNOLD A ROSERO (Provincial Director, Romblon PPO) stated that the meeting was adjourned and supported by all attendees.






