

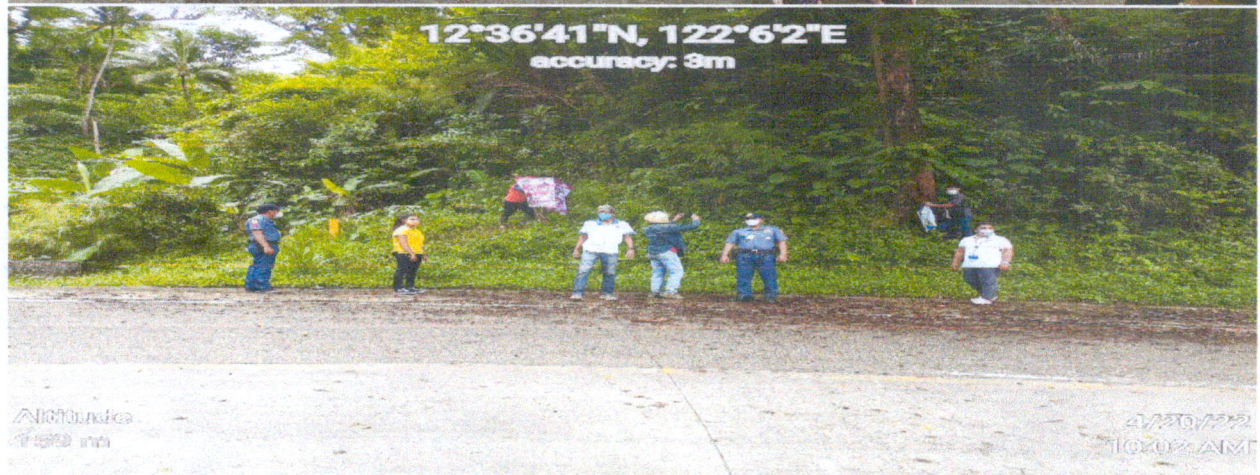

Alcantara	50

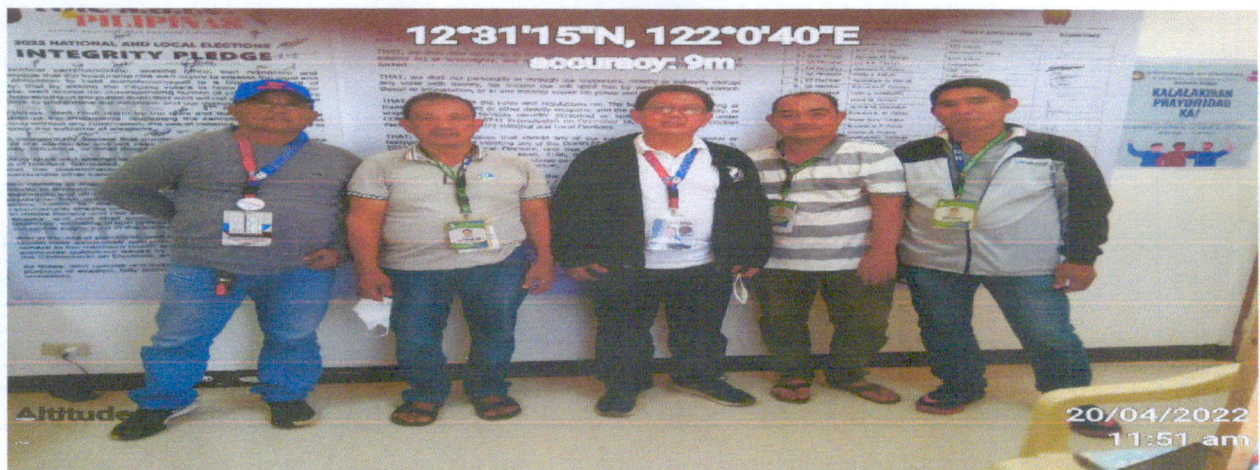
A total of approximately 920 posters/election materials were removed from trees. These posters were immediately turned over to the office of the COMELEC.

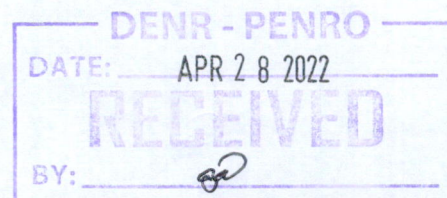




Estimated ads and posters removed and turn-over to Comelec Officer: 48 ads/posters
