Respectfully forwarded is the memorandum of CENRO Quezon, Palawan dated May 17, 2022 relative the above subject.


Per memorandum, the apprehension was made on March 27, 2022 at around 10:30 A.M. by the personnel of Monitoring and Enforcement Section of CENRO Quezon while conducting patrolling activities at Sitio Sinawacan, Barangay Iraan, Rizal, Palawan. The team apprehended twenty-two (22) pieces lumbers of Ipil species with different dimensions with estimated fair market value of Php10,421.00. However, no one seen in the place, and the team concluded the lumbers are abandoned.

The subject lumbers were deposited at DENR CENRO Quezon, Rizal Station, located at Barangay Punta Baja, Rizal, Palawan under the custody of ECOMS II Michael V. Joven for proper disposition and safekeeping.

Notices to the public dated April 4, 2022, April 12, 2022 and April 27, 2022 were posted to the public places. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government.

We concur with the CENRO recommendation for the issuance of Confiscation Order and Order of Finality of the apprehended forest product in favor of the government.

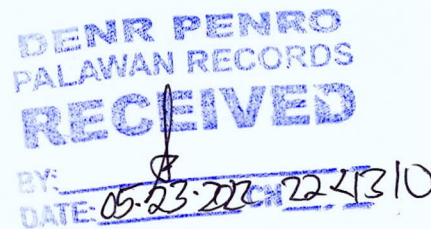

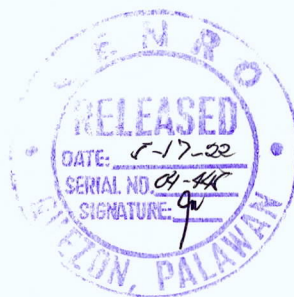

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF CASE

WHAT : Apprehension of Twenty-Two (22) pieces of Ipil lumbers having a total volume of 208.42 board feet with an estimated fair market value of Php 10,421.00.

WHEN : On or about 10:30 AM of March 27, 2022

WHO : No claimant/Abandoned

WHERE : Sitio Sinawacan, Brgy. Iraan, Rizal, Palawan

HOW : On March 27, 2022, the team of Monitoring and Enforcement Section while patrolling at around 10:30 AM at Barangay Iraan, had apprehended 22 pieces of Ipil lumbers having a total volume of 208.42 board feet. Per on-site investigation, no person/claimant found in the area, hence, declared abandoned. The apprehended lumbers were brought to DENR-CENRO Quezon, Rizal Station compound, Rizal, Palawan for safekeeping under the custody of ECOMS II Michael V. Joven. Subsequently, a Seizure Receipt and Seizure Order dated April 06, 2022 were issued by the undersigned.

II. NOTICE TO THE PUBLIC FOR THE CONDUCT OF HEARING:

Pursuant to the provisions of Department Administrative Order No. 97-32 Re: Rules for Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, item No. 03, posting of notice to the public for the conduct of administrative hearing for three (3) consecutive weeks at the different conspicuous place of Rizal, Palawan was conducted by this Office.

III. FINDINGS/EVALUATION:

In spite of the three (3) consecutive notices posted however, no claimant appeared before this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their right to the items apprehended in favor of the government.

IV. APPLICABLE LAWS:

Department Administrative Order No. 97-32 Section 8, item no. 3, Notice of Hearing shall be posted at least three (3) times, once every week for three (3) consecutive weeks, in at least three (3) public places, including, but not limited to: (a) the Barangay Hall of the apprehension site; (b) the Bulletin Board of the DENR Offices where the Proceedings will be conducted, and (c) at the Municipal Hall of the apprehension site.

V. RECOMMENDATION

In view hereof, it is recommended that the Twenty-Two (22) pieces of Ipil lumbers having total volume of 208.42 board feet with an estimated market value of Php 10,421.00 apprehended at Sitio Sinawacan, Brgy. Iraan, Rizal, Palawan be confiscated in favor of the government.

Hence, the foregoing forest products/conveyance/equipment are hereby ordered seized and now under government custody (except government-owned vehicles).

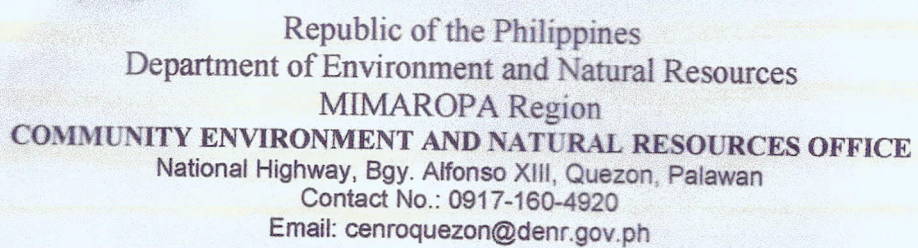
