Respectfully forwarded the memorandum of CENRO Coron, Palawan dated January 28, 2022 relative the above subject.

Per memorandum, the apprehension was made during the joint operation/LAWIN patrolling activities of CENRO Coron with the assistance of PNP Maritime Group and SRDC security personnel on April 6, 2021 at around 3:15 P.M. The team apprehended one (1) unit chainsaw (assembled) and eight (8) pieces lumbers of Santol Gubat species with total volume of 44 board feet with fair market value of Php20,000.00 and Php1,980.00 respectively. The apprehended items are now deposited at CENRO Office for safekeeping purposes.

Mr. Dijaye D. Lucena and Mr. Arjun "Kano" R. Bunye were caught in the act of slicing felled Santol Gubat tree using powered chainsaw. The PNP Maritime Group has already filed criminal complaints against the offenders for violation of Section 77 of PD 705, as amended and Section 7, paragraph 4 of RA 9175.

The hearing was conducted on November 5, 2021 and the notices of hearing were sent to the concerned parties in relation to Section 8, Item No. 3 of DAO 1997-32.

We concur again pursuant to memorandum dated June, 21, 2021 with the CENRO recommendation for the issuance of confiscation order.



Peace and order situation also contributed in the hauling process

2. Circumstances that led to the apprehension:

The joint operation and patrolling on April 6, 2021 was conducted with the report received by the undersigned from the security personnel that operation of timber poaching along the vicinities of Barangay Bintuan specifically observe within the forested territorial claim area of Sto. Rosario Development Corp. (SRDC) located along So. Malbato, Coron, Palawan. As a result of the organized joint Lawin patrolling to monitor and as confirmation to the alleged report, we successfully apprehended at around 3:15PM two (2) individual operators with one (1) unit undocumented chainsaw illegally cutting of trees within the forest land on the above said area. Offenders were oriented/brief with their rights then immediately brought down to the PNP Maritime Sub-Station for booking purposes while eight (8) pieces (out of 28 pieces) of newly sawn lumbers which will serve as an evidence were also taken and safe keep at DENR office. The team were unable to haul all lumbers due to the difficulty of time, terrain and distance from the site of poaching.



Respectfully forwarded the memorandum of CENRO Coron, Palawan dated June 21, 2021 relative the above subject.

Per memorandum, the apprehension was made during the joint operation/LAWIN patrolling activities of CENRO Coron with the assistance of PNP Maritime Group and SRDC Security Personnel on April 6, 2021 at around 3:15 P.M. The team apprehended one (1) unit chainsaw (assembled) and eight (8) pieces lumbers of Santol Gubat species with total volume of 44 board feet with fair market value of Php20,000.00 and Php1,980.00 respectively. The apprehended items are now deposited at CENR Office for safekeeping purposes.

Mr. Dijaye Lucena and Mr. Arjun "Kano" Bunye were caught in the act of slicing felled Santol Gubat tree using powered chainsaw. The PNP Maritime Group has already filed criminal complaints against the offenders for violation of 77 of PD 705, as amended formerly Section 68 and Section 7 paragraph 4 of R.A. 9175. (please refer to the attached filed criminal complaints)

In line with this, CENRO Coron is instructed to submit notice of hearing, minutes of administrative hearing, attendance sheet during the hearing and other pertinent documents in relation to DAO 1997-32.

We concur with the CENRO recommendation for the issuance of confiscation order subject the submission of remaining lacking documents described above.
