Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated May 13, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel on November 25, 2021 at around 3:56 P.M. by virtue of SW EJ No. 164-ROX-2021-21-DM in Barangay Ilian, Dumarán, Palawan.


The team apprehended twenty-two (22) pieces Apitong lumbers and two (2) pieces Apitong Hulls with equivalent volume of 970.66 board feet with estimated fair market value of Php48,533.00. The subject lumbers were hauled and deposited at CENRO Compound under the custody of Forester I Marces C. Lasangen.

The involved individual is Mr. Allan F. Echavez and the lumbers of Apitong are intended for the making of Bangka (Pumpboat) without permit and the corresponding criminal complaint was already filed at the proper court for violation of Section 77 of Presidential Decree No. 705, as amended against Mr. Echavez with NPS Docket No. IV-08-INV-21L-0688 on December 22, 2021.

Two (2) notices dated March 2, 2022 & March 10, 2022 for March 9, 2022 & March 17, 2022 administrative hearings respectively were sent to the concerned parties in relation to Section 8, Item No. 3 of DAO 1997-32.



Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

**I. FACTS OF THE CASE**

The apprehension was made by the DENR CENRO MES personnel by virtue on November 25, 2021 at around 3:56 P.M. by virtue of SW EJ No. 164-ROX-2021-21-DM. The subject forest products were brought to this Office compound for safekeeping under the custody of Forester I Marcos C. Lasangen.

**II. NOTICE OF HEARING**

Pursuant to the provisions of the Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 07, Item No. 01, issuance of Notice of Hearing for the conduct of administrative proceedings. Further, Notice of Hearing was issued and was scheduled on March 02, 2022.

**III. EVALUATION**

The administrative hearing was attended by the spouses Allan F. Echavez and Elisa M. Echavez.

Based on the conducted hearing, Mr. Allan Echavez stated that the apprehended lumbers were owned by the Alternative Learning Skill (ALS) of DEPED Dumaran which is intended for the construction of pump boat which will serve as their service. The said project was funded by the Local Government of Dumaran, Palawan.

During the same hearing, Mr. Echavez presented documents supporting his claims that he had just accepted the job. Among this documents are 1) Certification dated November 22, 2021 signed by Punong Barangay Tirso P. Parangue, Jr.; 2) Pakyaw Contract signed by Mayor Arnel T. Caabay and Mr. Allan F. Echavez which was Notarized on October 25, 2021; 3) Project Bill of Materials from the Municipal Engineering Office approved by and between Mayor Arnel T. Caabay with the Cost Estimates as attachment; and 5) Bid Form. Further, Mr. Echavez also said that the lumbers did not have any permit from the proper agency when it was delivered to his house by Mr. Larry Mendoza.

Moreover, this Office sent two (2) Notices of Hearing to Mr. Larry Mendoza dated March 2, 2022 and March 10, 2022 to hear his side relative to the said apprehension, however he failed to appear in this Office. Accordingly, Mr. Larry Mendoza was arrested for a different crime.

In summary, possession of lumber without any permit/document from this Office is a violation of Section 77 of Presidential Decree No. 77, as amended. Furthermore, a criminal complaint was already filed at the proper court against Mr. Allan Echavez with NPS Docket No. IV-08-INV-21L-0688 on December 22, 2021.

#### **IV. RECOMMENDATION**

Henceforth, recommending that the immediate issuance of Confiscation Order of the twenty-two (22) pieces of Apitong lumber and two (2) pieces of Apitong Banca hull (Casco) with equivalent volume of 496 board feet and 474.66 board feet, respectively, be forfeited in favor of the government.

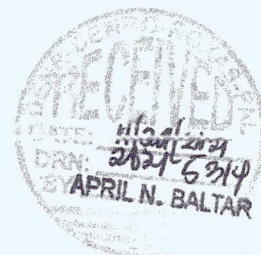

Please be informed that on November 22, 2021 in the morning, One (1) of the undersigned received an information thru phone call that a certain Mr. Allan Echavez,, a resident of Purok Sampaguitta, Barangay Ilian, Dumaran, Palawan is possessing undocumented lumbers in the premises of his residential house intended for construction of MB Motor Banca.

On the same date, at around 1:00 PM, the undersigned conducted further investigation and surveillance about the said information. During interview to Barangay Kagawad Aboror and Randy B. Manlavi, Barangay Officials of the same mentioned Barangay, accordingly the owner of the residential house and premises where the said undocumented lumber being stacked is Mr. Allan Echavez and the said undocumented lumber are to be utilized in the construction of Motor Banca of Alternative Learning System (ALS).

During further surveillance of the undersigned, the said undocumented lumber were identified as Apitong and Bantulin Species. After data gathering, the team vacated the area and return to the CENRO Office to prepare document needed in securing Search Warrant.

On November 24, 2021 the undersigned secured Search Warrant against Mr. Allan Echavez for Violation of P.D 705.

Around 3:56 PM of November 25, 2021, during the serving of SW EJ NO. 164-ROX-2021-21-DM by Forest Technician II Roy Mercader, Mr. Allan Echavez is in Puerto Princesa City so, his 22 years old son, Mr. Allan Jude Echavez, was the one who received the said Search Warrant and witnessed by the Barangay Chairman, Tirso Parangue, and Barangay Kagawads, Mr. Randy Manlavi and Ms. Lileth Mampay, Dumaran Municipal Police Station Personnel led by PSGC Ramon Canales and the undersigned. During the search on the property of Mr. Allan Echavez at the side and at the back of his house we found the subject lumbers.

By the virtue of **SW EJ NO. 164-ROX-2021-21-DM** duly signed by Executive Judge Anna Leah Y. Tionson-Mendoza issued on November 24, 2021, the team apprehended two (2) banca hulls (casco) in different dimensions and Twenty-two (22) pieces of Apitong lumbers in assorted dimensions with overall estimated volume of 970.66 Board Feet.

The team observed that some apprehended/seized lumbers were very long and not feasible to be loaded to the truck/conveyance utilized in hauling and considering the terrain and condition of the road which is muddy and slippery, the undersigned decided, for safety purposes, to cut into two pieces using Crosscut saw, witnessed by Barangay Chairman, Tirso Parangue, Barangay Kagawad Randy Manlavi, PSSG Ramon Canales, and Mr. Allan Jude Echavez.

The undersigned, accordingly, observed and followed all required procedure of serving the SEARCH WARRANT particularly the **SUPREME COURT A.M. NO. 21-06-08-SC**.

In light of the above, Mr. Allan Echavez violated Section 77 of Presidential Decree No. 705, as amended by Republic Act No. 7161. We hereby recommend to file criminal charged against Mr. Allan Echavez before the proper Court of Law.

The apprehended lumber were brought to the DENR-CENRO Roxas Compound for safekeeping and proper disposition.

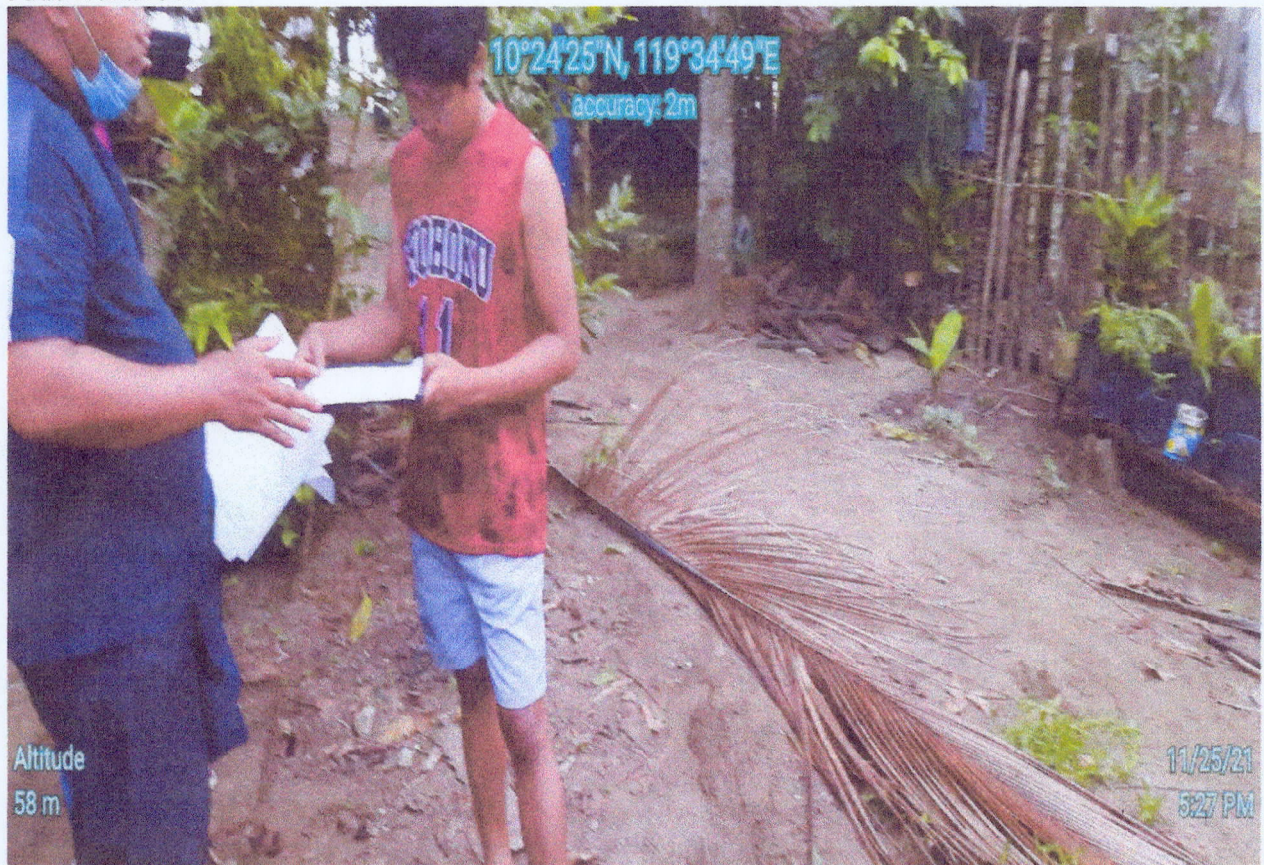






Loading of the seized items.





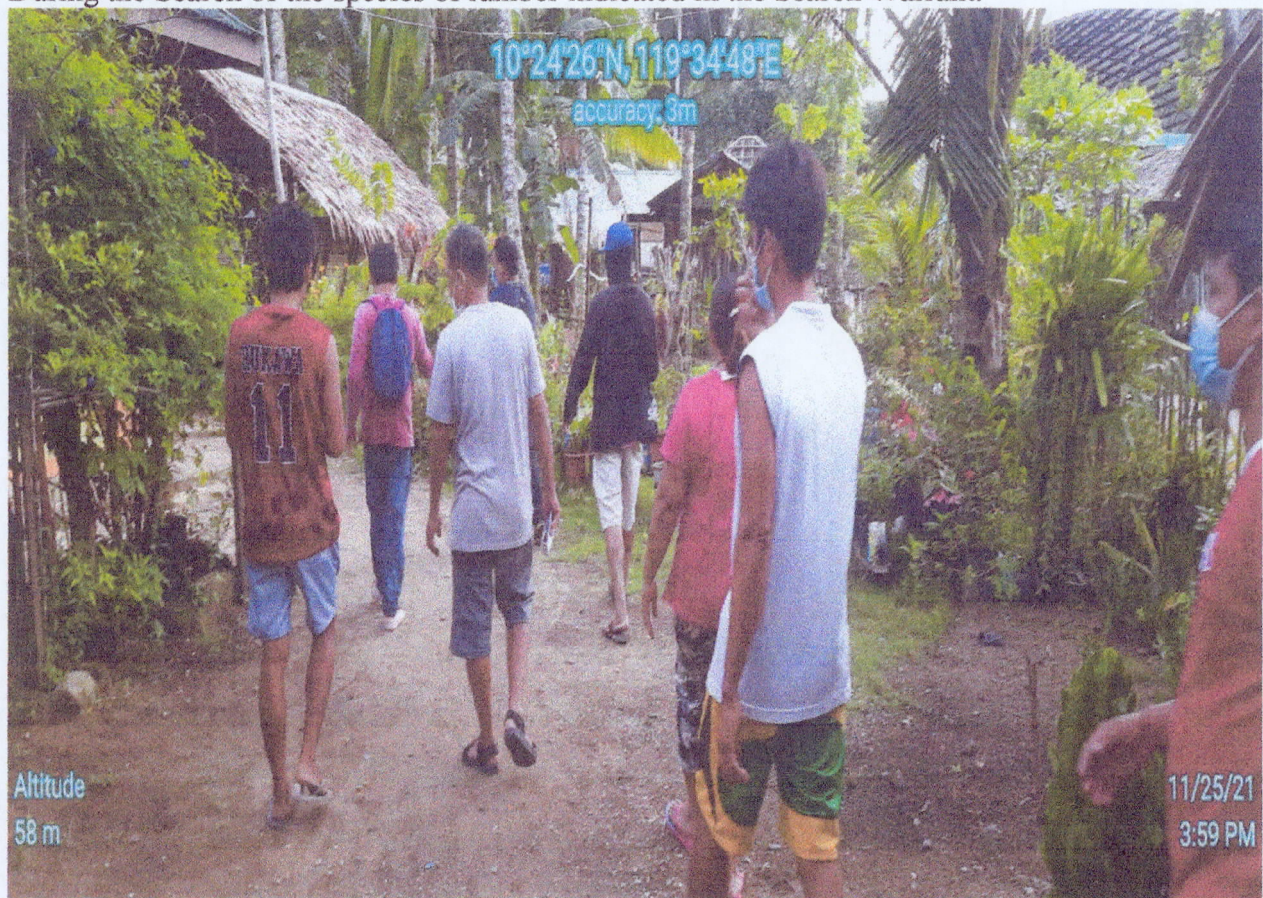
