



In compliance with the Memorandum of the Undersecretary for Field Operations and Environment to the Regional Executive Director dated April 08, 2022 regarding the subject. Please be informed that on April 25-26, 2021 the personnel of Monitoring and Enforcement Section (MES) conducted the "OPLAN BAKLAS" on the election ads posted on trees and implementation of a zero waste election system within the administrative jurisdiction of this Office.

Be informed that 122 pieces of posted election ads were removed in the Municipality of Roxas in the areas of Barangays Tinitian, San Miguel, Jolo, Nicanor Zabala, Caramay, Magara, Tagumpay, San Jose, Malcampo, Barangay 4, Minara, Sandoval, and Dumarao. In the Municipality of San Vicente 12 pieces posted of election ads were also removed in Barangay Port Barton, Kemdeng and New Agutaya. While in the Municipality of Dumaran there is no posted election ads on trees as observed by the assigned patrol sector. Overall, 134 pieces of posted election ads were removed in the administrative jurisdiction of this Office.

It is observed that most of the removed election ads were installed/posted on forest trees and planted trees mostly along the Provincial and Barangay Roads.

All the above mentioned removed posted election ads were brought to the DENR-CENRO Roxas Compound situated at Barangay III, Roxas, Palawan.


