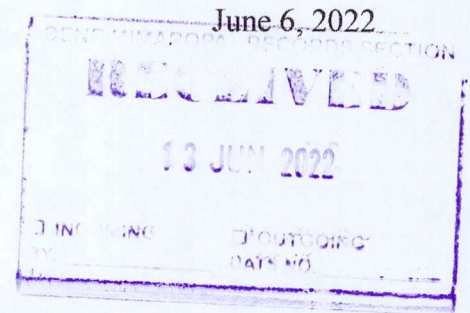



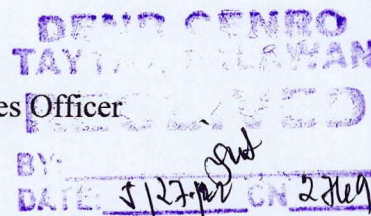

This pertains to the target activity on Communication, Education and Public Awareness (CEPA) under 001 Protected Area Management and Development Sub-Program of Malampaya Sound protected Landscape and Seascape (MSPLS). Taytay-San Vicente, Palawan.

Please be informed that on May 26, 2022, this Office together with Mr. David Maurice C. Tolentino of Malampaya Foundation, Inc. facilitated the conduct of the abovementioned subject to the BLGUs of Liminangcong and Tumbod held at Multi-Purpose Hall building of Barangay Liminangcong, Taytay, Palawan. It was attended by nine (9) females and twelve (12) males.

The topics discussed was the Republic Act 7586 or NIPAS Act of 1992 as amended by Republic Act 11038 or ENIPAS Act of 2018 presented by Protected Area Superintendent Clarissa P. Pador informing the participants about the prohibited acts and penalties particularly the Section 20 and 21 of the said act. Likewise, Mr. David Maurice C. Tolentino presented the accomplishment and result of their activities conducted within outer MSPLS as well as the issues and impact on the marine resources especially on the corals which being monitored and recorded by their Office, based on the presentation it shows the variability of the result and observations in the corals since it was monitored and even the observation of its deterioration such as coral bleaching.

Further, an issues and concern was brought out during the open forum and started with the clarification for land classification of Barangay Liminangcong in which Barangay Kagawad Nenita Peña asked question on what tenurial instrument can be applied by the communities on their barangay that falls within Timberland area as well as the implementation of the 40 meter easement to the household residing in the coastal areas as mentioned on the Section 20, item v of RA 11038, meanwhile Mr. Rafael Orubia, BFARMC President of Barangay Liminangcong also asked who is the leading agency when it comes to enforcement matter in the protected area?. The raised issues was addressed by PASu Pador through explaining the application of Special Use Agreement within Protected Areas (SAPA) that is suitable for business entrepreneurs for they have the ability to pay for an Annual fee and improvement of their project, likewise she advised the Barangay Council of Liminangcong regarding the identified relocation site of the barangay


that they should submit a letter address to the PAMB chairperson citing that the identified area is requested purposely for relocation area of residential within the easement noting that whole barangay is Timberland. In addition, Mr. Tolentino address the issue on enforcement matter raised by Mr. Orubia, according to him it is necessary for the neighboring barangays as well as other partner agencies to have cooperation and collaboration in order to implement the law properly, it was agreed by PASu Pador and asserted that Protected Area Management Office (PAMO)-MSPLS and DENR is not the only leading agency that can implement the law, it is also the duties and responsibilities of the Barangay Council to do the same in terms of protecting the environment and suppress the illegal activities monitored within the barangays.

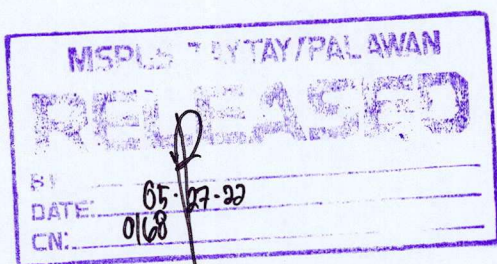
On the other hand, Mr. Tolentino presented the action plan in relation to the schedule of activities for any recommendation and suggestion of the BLGUs of Liminangcong and Tumbod and PASu. It was agreed that the said action plan will be distributed to the participants and PASu for information and guidance in accomplishing the activity.

The said activity aimed and ensure that all resident should be aware and properly informed on the importance and proper conservation of marine resources that everybody will benefit and the next generation, and continuously disseminating the information of laws in order to protect the natural resources.

Hence, this Office recommends to continuously increase the awareness through Information, Education and Communication (IEC) campaign to the BLGUs and other partner agencies and strengthen the law enforcement activity within MSPLS.


