

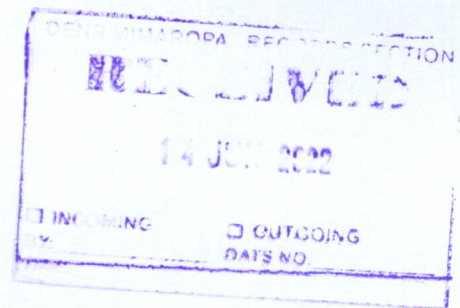

Kami po, mga lehitimong residente ng Barangay Poblacion 2 (Malvar Street), Coron, Palawan ay dumudulog at humihiling na sana po ay mapakinggan ng inyong mabuting tanggapan ang aming mga saloobin.

Nakarating po sa aming kaalaman na nacancell po ang ECC ng reclamation sa aming karatig lugar, sa totoolamang po, masaya at napakalaking tulong po sa amin ang gagawing reclamation dahil po magiging lupa na ang aming tinirahan, panatag na po kami sa kaligtasan ng aming mga anak na maliliit at aming mga senior citizens dahil wala nap o ang dagat na maaari nilang kahulugan na maaaring ikalunod. Malaya na rinpong nakakapaglaro an gaming mga kabataan. At kung sakali man pong may darating na bagyo katulad ng nakaraang bagyong YOLANDA ay di nap o manganganib an gaming buhay at mumunting ari-arian pati na rin ang mga bangkang ikinabubuhay ng bawat residente ng Barangay POBLACION 2. Sa tuwing sasapit po ang low tide ay dina po naming kailangang hilain pa an gaming mga Bangka tuwing kami ay dudunggo mula sa pangangisda at hindi na rin po kami kailangang maglakad sa putikan tuwing kami ay lalaot sa mga panahong iyon. Sa tuwing darating din

po ang bagyo ay dina namin kinakailangang itago pa kung saan saan ang amin munting Bangka, itataas na lamang naming ang mga ito sa itinambak na mga lupa. At sa nakaumang na panganib naman po tuwing may sunog ay panatag na po kami na makakapasok ang firetruck sa bawat kalsada sa pagitan ng mga kabahayan.

Amin din pong lubos na hinihingi ang inyong pang-unawa upang hindi na po kami mapaalis sa aming tinitirahan sapagkat nandito po ang aming mga kabuhayan at malakirin po ang magiging epekto sa pagpasok sa eskwela ng aming mga anak kung sakali kami ay mapapaalis. Wala rin po kaming kakayahan upang magsimula ng panibagong kabuhayan sa ibang lugar.

Kaugnay nito, hinihiling din po sana namin na sana po ay maipagpatuloy ang proyektong itinatalaga ng pamahalaan para sa reclamation dahil sa aming pang unawa ay Malaki po ang maitutulong nito sa aming kabuhayan at pag unlad. Na hindi lamang po kaming mga magulang ang makikinabang at siguradong pati ang aming mga anak at susunod na mga henerasyon ay may malaking kapakinabangan. Batid po namin ang mga positibong maiaambag nito sa aming kabuhayan at pag unlad. Bilang mga residente po ng Malvar Street Barangay Poblacion 2, kami po ay magpapatunay na wala pong corals sa nasabing lugar na kung saan nagkaroon ng reclamation, patunay po nito ay ang lawak na sakop ng kaputikan sa tuwing mag lolowtide, dagdag na katibayan po ang mga litratong kuha noong mga nakaraang taon (2014-2019), na kung saan bukod po sa aming barangay ay may mga ibang ahensya (pribado at lokal na ahensya) din po ang nagsasagawa ng coastal clean-up sa aming lugar. Umabot na rin po sa 25,269 ang coliform level ng aming barangay at mabaho at maitim na po ang tubig sa baybayin, na makakapagdulot din ng sakit sa amin. Ngunit dahil po sa reclamation maaaring mapanatili na itong malinis dahilan ang mga basura ay naiipon na po at nakokolekta na ng truck ng basura ng Munisipyo dahil maiwasan na ang pagtapon ng basura sa karagatan. Malaki ang maitutulong din ng reclamation dahil malilit na po ang kasalukuyang kalsada ng Coron at sa dami na po ng turista na pumapasok sa aming bayan Malaki na po ang epekto nito sa trapiko ng Coron, na kung maitutuloy ang proyekto ng reclamation ay maaaring makatulong ito para sa alternatibong ruta.

Ang nais lang po naming bilang mga lehitimong residente ng Barangay Poblacion 2 ay maging maayos at ligtas ang bawat isa sa amin at maging produktibo sa tulong ng mga itatayong proyekto ng reclamation at maging metatag para sa kinabukasan.

Kami po na lehitimong residente ng maraming taon ng Barangay Poblacion 2, Coron Palawan ay naninikluhod at nakikiusap na sana po ay pakinggan at maintindihan ang aming mga hinaing para sa kapakanan ng bawat isa sa amin.

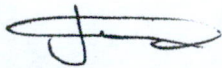
As the officials of this barangay, all we are praying and requesting for is better place, a safer place and a productive place for our constituents to live in.
