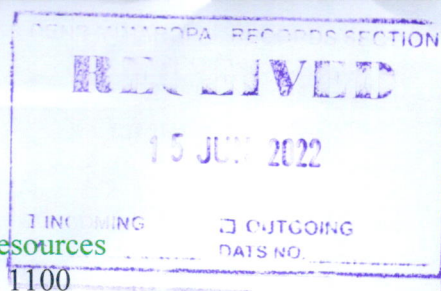

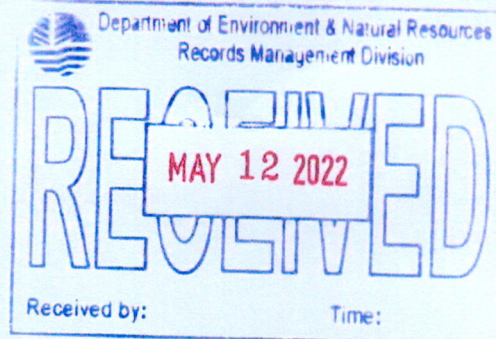



A RESOLUTION

AUTHORIZING THE PROVINCIAL GOVERNOR, OR HER DULY AUTHORIZED REPRESENTATIVE, TO ENTER INTO, AND SIGN A SUPPLEMENTAL MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), AND THE CITY GOVERNMENT OF ANTIPOLLO RELATIVE TO THE HINULUGANG TAKTAK PROTECTED LANDSCAPE, AND FOR OTHER PURPOSES

WHEREAS, Section 16 Article II of the 1987 Constitution provides that the State shall protect and advance the rights of the people to a balance and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, by virtue of R.A. 11038, otherwise known as the Expanded National Integrated Protected Area System Act (ENIPAS) Act of 2018, Hinulugang Taktak Protected Landscape was established as a protected area within the classification of a national park;

WHEREAS, as a continuing program of the Rizal Provincial Government for a far better healthy ecology, there is a need to collaborate and coordinate with other governmental instrumentalities in the protection and conservation of the environment, in consonance with the YES To Green Program;

WHEREAS, Section 465 (b) (1) (vi) of R.A. 7160, likewise provides




