In compliance with the Memorandum addressed to the PENR Officer on February 5, 2020 regarding the above-mentioned subject, Completed Staff Work is hereby submitted with the following informations:

FACTUAL BACKGROUND

Records of this Office disclosed that NILO ALBA filed his Free Patent Application No. (IV-A-6) 2025 on January 20, 1977 from which Free Patent No. (IV-A-6) 1621 was subsequently issued on August 20, 1977 covering Lot No. 731-J, SWO-04-000238, equivalent to Lot 3634, CADM-506-D, Roxas Cadastre.

LEGAL BASIS

Claims of ownership over the said land cannot be supported by his heirs because the patent itself was never transmitted to the Registry of Deeds, Calapan, Or. Mindoro for registration pursuant to the Provisions of Act No. 496 and is now therefore seeking remedies thus, revocation of the afore-said patent is very much necessary.

AGENCIES INVOLVED

This Office particularly the Records Section attested the fact that the said patent for unknown reason/s was never transmitted by the then District Land Office to the Registry of Deeds concerned for registration as evidenced by those Original and Duplicate copies of Judicial Form with Serial No. 004973 found inside the carpeta of the said applicant/patentee.

Heirs of Nilo Alba are continuously paying taxes to the government.

POTENTIAL PROBLEM/S

There will be no potential problem that will arise as soon as the above-mentioned patent issued in the name of Nilo Alba is revoked, and instead it will be beneficial to his heirs represented by Mrs. Martina Alba Mendoza because they can file public land application for the said land.

OCULAR INSPECTION

On August 28, 2019, I was on and personally conducted inspection on the premises of the subject lot and it was found out that his heirs are still in actual occupation, cultivation and possession of Lot No. 731-J, SWO-04-000238, CADM-506-D, Roxas Cadastre.

There is no part or portion of the said land in any way transferred or waived to another person/s.

RECOMMENDATION

Considering the fact that the Original and Duplicate Copies of Judicial Form No. 004973 were found intact in the carpeta of Nilo Alba, it is evident that the said Free Patent No. (IV-A-6) 1621was never transmitted to the Registry of Deeds, Calapan, Oriental Mindoro for registration.

Wherefore, it is hereby recommended that the Free Patent No. (IV-A-6) 1621 issued in the name of Nilo Alba be, revoked in accordance with standing laws, rules and policies thereby giving preferences to the Heirs of Nilo Alba represented by Martina Alba Mendoza to file appropriate public land application.
