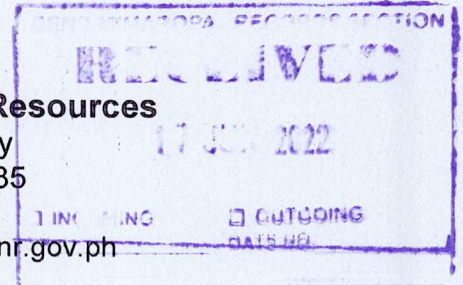




Dear Atty. Angeles:

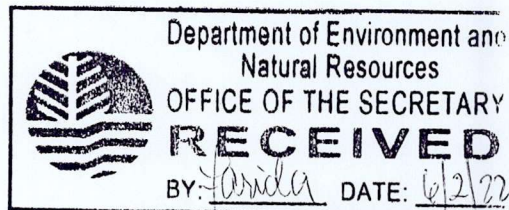
