Submitted is the report of CENRO Socorro on the establishment of one (1) Forest Nursery, the said activity is based on the Work and Financial Plan (WFP) CY 2022 target under MOOE.

Based on the report, the CY 2022 target for the establishment of forest nursery was already accomplished and now operationalized. The one hectare forest nursery is located at Brgy. Paitan, Naujan, Oriental Mindoro. Nursery facilities and basic structure are now installed such as the following: semi-permanent building, temporary shed/potting shed and water supply. Moreover, perimeter fence was also installed to protect the seedlings from stray animals. Important nursery tools for daily operations of the nursery were purchased such as wheel barrow, bolo, shovel, shade net and polyethylene bags of different sizes.

In addition, a nursery foreman was hired to conduct the daily operations and maintenance of the nursery facilities. He is also responsible for the production of the target seedlings.

This pertains to the memorandum of Marcial C. Amaro Jr. CESO III dated June 14, 2021 that the secretary instructed the reactivation of the Department's seedling production and distribution program in order to supply the requests of private individuals, other government agencies, NGOs and other stakeholders effective CY 2022.

In line with this memorandum a one hectare forest nursery target of CENRO Socorro for CY 2022 was established at Paitan, Naujan, Oriental Mindoro. On CY 2021 a Forest Nursery Operation Plan was submitted at PENR Office. All activities stipulated in forest nursery operation plan were delivered on prescribed time indicated on the said operation plan. We already erected a semi-permanent building wide enough to house project personnel and laborers. Another temporary shed was constructed and served as nursery potting shed. Water supply was installed already through the SWIS project of DENR CENRO Socorro. It will be used for watering of seedlings. Fence was established to protect the seedlings within the one hectare forest nursery. Important tools for nursery operation were procured such as wheel barrow, bolo, shovel and poly ethylene bags of different sizes for the operation of the nursery.

A nursery Operation Foreman was hired under contract for eight months. He will be responsible in the establishment, operation and maintenance of the nursery. In addition, he is also responsible in the production of the required number of seedlings for the project and prepares and submits the list of the manpower requirements of the nursery.

Indigenous tree species were produced at the nursery. It was collected as wildlings and potted at the nursery with extra care.

Attached herewith are geo-tagged photos of before, during and after the establishment of the CENRO Socorro nursery.





