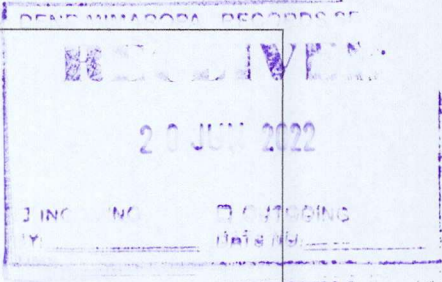

ORDER OF AMICABLE SETTLEMENT¹

AMICABLE SETTLEMENT AGREEMENT²

The same shall constitute as full and final settlement of any Protest or Complaint each party may have against the other in relation to the subject lot. "
