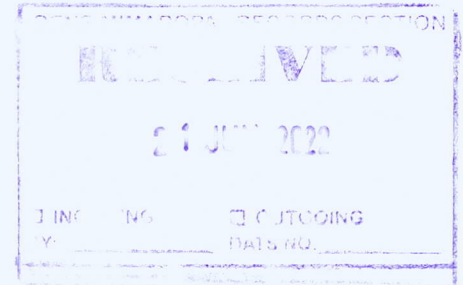

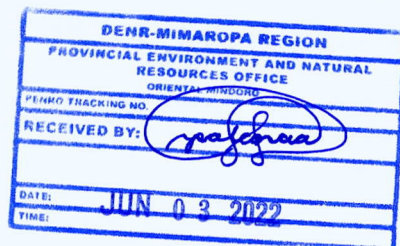

As part of strengthening the anti- illegal logging campaign and forest protection activities, the Monitoring and Enforcement Section conducted a multi-sectoral consultative meeting held at the Sanggunian Bayan Session Hall of Gloria, Oriental Mindoro on May 24, 2022.
