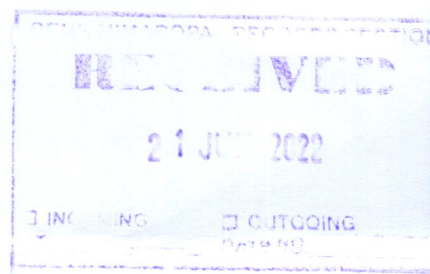


This refers to your Memorandum dated 26 April 2022 submitting the Annual Accomplishment Report of El Nido-Taytay Managed Resource Protected Area (ENTMRPA) for CY 2021.

Based on review of the said report, we are providing below our comments and recommendations:

1. Implementation of Biodiversity Monitoring System (BMS)	It was noted that the observations for Transect swim provided in Table 2 were interchanged with Transect Walk.	Kindly advise the PAMO to rectify the information provided in Table 2 and to intensify the IEC and patrolling activities specially in areas where there are notable clearing activities. The results of the BMS should be presented to the PAMB for their management intervention and guidance.
2. Quorum for PAMB Meetings	It was noted that the total number of PAMB members was not clarified, hence there was uncertainty in declaring quorum.	It maybe recalled that this Office has issued a Memorandum dated June 22, 2021 on Agreements reached during the Regional Consultation Hour held on 23 February 2021 which is to submit the list of PAMB ex-officio members and supporting

		documents of representatives and other non-ex-officio members. Relative to the said Memorandum, may we request the submission of the said list of PAMB ex-officio members and supporting documents of representatives and other non-ex-officio members for endorsement to the DENR Secretary for appointment.
3. Activities under the CY 2021 Work and Financial Plan (WFP) chargeable against the Integrated Protected Area Fund (IPAF)	We noted that procurement of motor vehicles was charged from IPAF-RIA in FY 2021. The Authority to Purchase Motor Vehicle was requested to Department of Budget and Management (DBM) and approved on December 16, 2021 with conditions provided. Copy of the approved Authority to Purchase Motor Vehicle is attached for ready reference.	May we request updates/report on the status of the procurement of motor vehicles and the PAMO's compliance with the conditions set by the DBM.
4. Activities under the Ecotourism Development Fund (ETDF)	We noted that the 10% share of ENTMRPA-PAMO from the ETDF of LGU of El Nido has been utilized to hire additional PAMO staff and procure supplies and materials, among others.	May we follow up our request for clarification through Memorandum dated 14 June 2021 on the relation of the ETDF being collected by the Municipality of El Nido to various fees being collected by the PAMO of ENTMRPA that accrue to its IPAF.

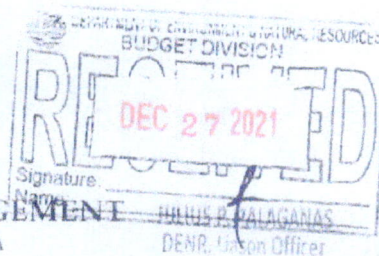

CONDITIONS:

1. The motor vehicle/s shall be used only for official purpose, the intended use and/or by the intended user, for which the motor vehicle/s was requested as herein authorized. The acquisition/purchase of subject motor vehicle/s shall be in accordance with the provisions of, among others, Administrative Order (AO) No. 14 dated December 10, 2018; Budget Circular (BC) No. 2019-3 dated May 16, 2019; BC No. 2019-2 dated March 4, 2019; Office of the President Memorandum Circular No. 9 dated December 14, 2010; BC No. 2010-2 dated March 1, 2010; and National Budget Circular (NBC) No. 446 dated November 24, 1995, as amended by NBC No. 446-A dated January 30, 1998. Further, the classification/s and specifications of subject motor vehicle/s shall be consistent with the provisions of BC No. 2019-2, and Annex B of BC No. 2017-1.
2. Moreover, it is understood that the acquisition of said motor vehicle/s shall be in accordance with the Government Procurement Reform Act (Republic Act No. 9184) and its Implementing Rules and Regulations, as well as subject to the usual budgeting, accounting, auditing, and other applicable laws, rules and regulations.
3. The purchase of motor vehicle/s shall in no case be used as justification to request for additional driver positions.
4. The agency shall submit **within 30 days from the date of acquisition**, a written report on the purchased motor vehicle/s to this Department (through Budget and Management Bureau – E), pursuant to NBC No. 438 dated January 11, 1995.

5. The agency shall also submit within **six (6) months a report on the disposal of the motor vehicle/s being replaced by the unit/s (if any)** under this authority, pursuant to AO No. 15 dated May 25, 2011.

This refers to the Memorandum from the PENRO Palawan dated 2 March 2021 forwarding the report on the meeting conducted by the Ecotourism Development Fee (EDTF) Management Board of the Municipality of El Nido.

We noted that ETDF is a payment for "tourist ticket" issued to all tourists who visit and enjoy the natural scenery of El Nido and is being collected by the Municipality of El Nido by virtue of Municipal Ordinance No. 005, Series of 2011.

Relative thereto, may we request further clarification on the relation of the ETDF to the various fees being collected by the PAMO of El Nido-Taytay Managed Resource Protected Area that accrue to the IPAF. Further, you are advised to review the above-mentioned Ordinance in relation to Section 26 of the NIPAS Act, as amended and BMB Technical Bulletin No. 2017-12 "Clarifying the Revenue-Sharing between the Protected Area Management Boards (PAMBs) and Local Government Units (LGUs) with Investments in Protected Area".
