Forwarded is the Memorandum of CENRO Brooke's Point, Palawan dated August 10, 2021 acknowledging the Memorandum from the Regional Executive Director dated April 22, 2021 and further requesting for the re-projection of the subject lots.

Further, upon evaluation and re-projection by this Office using Geographic Information System (GIS) BLLM No. 1 of PLS 618-D, Brooke's Point with coordinates N=426837.44783, E=970059.06635 it was found out that subject lots fall to Bgy. Mambalot and is within Alienable and Disposable Land per LC Map No. 2046, Project No. 12-J, Block II certified on November 23, 1956 (F.A.O. No. 4-563). However, re-projection using BLLM No. 1, PLS 618-D, Sofronio Española with coordinates N=456632.46049, E=1009034.66118 subject lots fall to Bgy. Aramaywan, Narra, Palawan and found to be within forestland.

In view of the foregoing, clarification is requested as to the approved coordinates of BLLM No. 1, PLS 618-D to be used as point of reference for projection.



This is to acknowledge receipt of the Memorandum dated April 22, 2021 informing that the Regional Office could not provide the confirmation of Land Classification status of the subject lots as they were projected to fall within forestland per Land Classification Map No. 2739, Project No. 12-M certified on March 6, 1972 based on the submitted tie line appearing in the approved plan.

Verification on the One Control Map appearing in the GIS Shape file of Land Classification Maps programmed in our computers show that Project No. 10-M, LC Map No. 2739 falls within the Municipality of Narra, Palawan.

Further verification/ comparison of GIS shape files of BLLM's in the One Control Map show that there were two (2) BLLM No. 1 attributed to be of PLS 618-D. One was located at Barangay Isumbo, Sofronio Española from which coordinates the result appearing in the Memorandum may have been derived, and another one located at Poblacion I, Brooke's Point, please see attached computer generated copies of Cadastral Maps marked ANNEX 1 and 2, respectively.

In view of the foregoing, it is respectfully requested that the lots be reprojected using the coordinates of the BLLM No. 1 as appearing in ANNEX 2 and described on the original technical description of Lot 379, PLS 618-D, copy of which is also hereto attached marked ANNEX 3, per chance the lots would be found within the Alienable and Disposable Zone under Project No. 12-J, Block II, LC Map No. 2046, FAO No. 4-563 certified on November 23, 1956.










