



This pertains to the PENRO Memorandum dated March 25, 2022 anent to the Memoranda from the OIC-Regional Executive Director dated March 11, 2022 and the previous instruction from then Regional Executive Director Maria Lourdes G. Ferrer, CESO III dated June 22, 2021 and October 29, 2021 pertaining to the "Conduct of Monitoring and Data Gathering Activities for Foreshore Management".

Respectfully submitted is the **Updated Inventory of Foreshore Lease Applications, Updated Inventory of Actual Users of Foreshore Areas and shape files of the FLI's** (saved in CD) particularly those with Lease Contract Agreement and the previous foreshore areas subjected to appraisal and re-appraisal for the year 2021 within the jurisdiction of CENRO Puerto Princesa.

Please be informed that most of the filed Foreshore/Miscellaneous Lease Applications were subjected to ground validation and found out that there are instances that the subject areas are covered with mangroves, the adjacent lot is already sold and/or transferred and some owners/applicants are no longer interested to continue their applications considering that the total amount of pre-computed appraised value is very high because of the tremendous increased in the BIR Zonal valuation in the province of Palawan. On the other hand, some of the applicants only filed for FLA or MLA purposely to have legal documents to protect their frontage, for private bathing and swimming and though some are for commercial purposes. Copy of the submitted letters from applicants who are no longer interested to continue their applications are hereto attached.




Moreover, most of the filed Foreshore/Miscellaneous Lease Applications are pending for a long period of time and since then, no occupational fee has been collected by this office. Some of the applicants are not actually residing in the adjacent property hence, the land is only an investment and they only applied the aforementioned application just to have a legal papers to keep away the informal settlers who may possibly encroach the salvage zone/foreshore area.

Furthermore, most of the listed applicants were not fully informed about the actual process of the Foreshore/Miscellaneous Lease Applications in which some of them thought that they already had the 25 years Lease Contract once they already had an approved plan. In addition, some thought that they can own the foreshore area that they applied as allegedly advised by the former investigator of this office.

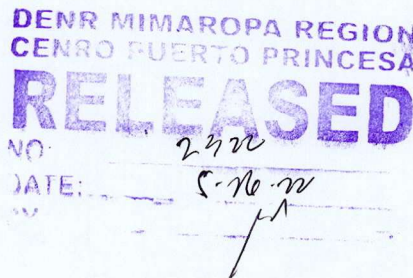
Finally, those pending applications which are no longer active and that no compliance of the documentary requirements from the applicant/s are recommended for cancellation/rejection considering that per DAO No. 2004-24 under Section 16, Item 2, Non-payment of annual lease rental for two (2) consecutive years is one of the ground for cancellation.
