REITERATING SUPPORT TO THE POSITION PAPER ON ENVIRONMENTAL CONCERNS REGARDING EASEMENT, THIS MUNICIPALITY.

WHEREAS, in 2018, the Municipal Government of Coron, Palawan presented its POSITION pertaining to environmental concerns in the municipality brought about by the investigation and study on the environmental status of Coron which was conducted by the DENR-MIMAROPA Task Force in compliance with the directive of President Rodrigo Roa Duterte to ensure the environmental protection of all tourism destinations in the archipelago;

WHEREAS, the investigation reported alleged violations of residential and commercial establishments with regards to easement zone including timberland occupancy violations, prompting the issuance of a "Notice to Vacate" by the DENR and subsequently the presentation of Position Paper by the LGU regarding the matter;

WHEREAS, facts and salient points were clearly stated in the aforesaid document expressing justifications and reflecting the sentiments of the people on issues raised by the DENR based on its investigation, particularly, on the consequences of displacement of hundreds of families and the probable adverse effects on the source of income and livelihood of the majority;

WHEREAS, this August Body deemed it appropriate to express support to the significant action taken by the LGU during this crucial period wherein the municipality and its constituents were on the verge of facing difficult times if ever the order to vacate for easement/setback purposes was enforced;
