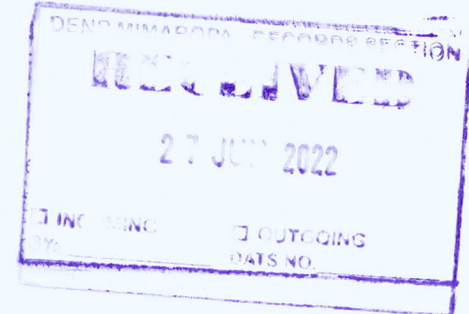



Please be informed that on May 23, 2022, the PAMO-MSPLS personnel patrolled one (1) site with an estimated distance of 1.5 kilometers and monitored one (1) motorized banca owned and operated by a certain Mr. William C. Verzosa, caught in the act of conducting mano-mano or spearfishing in the vicinities of the established Strict Protection Zone (SPZ) at Barge Reef, which is strictly prohibited.

Moreover, the violator was brought to the Barangay Hall of Liminangcong for documentation purposes, and an agreement was made between the violator, Punong Barangay of Liminangcong and PAMO-MSPLS staff.

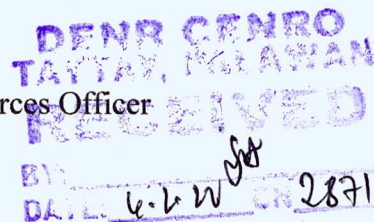



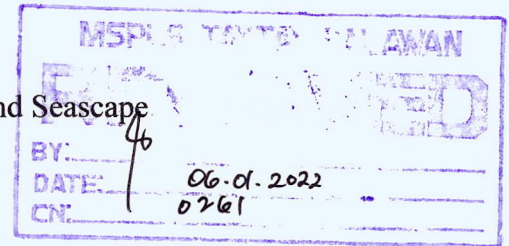

This pertains to the target activity on the Maintenance and Protection for Coastal and Marine Ecosystem (e.g. reduction of threats and enforcement) - Patrolling under 001 Management of Coastal and Marine Resources Area/s of Malampaya Sound Protected Landscape and Seascape (MSPLS), Taytay-San Vicente, Palawan.

Please be informed that on May 23, 2022, we, the undersigned conducted night seaborne patrol and verification within the Strict Protection Zone at Barge reef, Barangay Tumbod, Taytay, Palawan. At around 9:00 in the evening, we spotted a light coming from a flashlight under the water at Barge reef estimated 1.5 kilometers from the ranger station. We decided to check and verified the location of the light and found one (1) motorized boat owned and operated by William C. Verzosa, a resident of Barangay Liminangcong, Taytay, Palawan conducting spear fishing.

We explained that any fishing activity inside the Strict Protection Zone at Barge reef is prohibited and we brought him at Barangay Hall of Liminangcong for documentation purposes. Likewise, an agreement was made between the violator, Punong Barangay of Liminangcong and PAMO-MSPLS staff. The violator promised not to engage again in such fishing activities and would cooperate to the concern agencies for any information regarding fishing activities in the area.

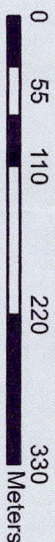

## LOCATION MAP

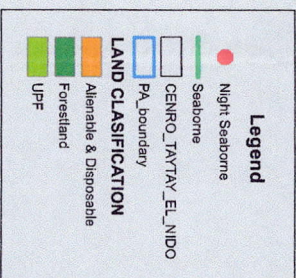
SHOWING THE CONDUCTED NIGHT SEABORNE




