# PROGRESS REPORT ON THE GREEN ECONOMY MODEL (GEM) PROJECT ACTIVITIES OF CORON, PALAWAN CY 2021

Pursuant to Republic Act No. 10771 otherwise known as "Philippine Green Jobs Act of 2016" and DAO 2017-08 to operationalize the transition of DENR programs and projects into Green Economy Model (GEM) where household members create sustainable goods and services for the rehabilitation of degraded ecosystems; create viable community enterprise where household are the focal members and players in creating value-added environmental products and services; and accelerate the rehabilitation of degraded of degraded ecosystems and promote the protection of environment through the creation of green jobs.

These undertakings were started since 2018 by creation of Task Force Coron led by Engr. Roman G. Legaspi thru Regional Special Order No. 097, S. 2018 dated February 26, 2018 as per directive of President Rodrigo R. Duterte for the conduct of clean up drive along foreshore areas of our country's top tourist destinations which includes Coron, El Nido and Puerto Galera to protect health of locals and visitors as well as our environment.

The implementation of CY 2021 targets activities of GEM were spearheaded by the GEM Task Force of Coron Palawan with CENRO Special Order No. 23 S. 2021 composes of 6 committees:

- a. Command Center Committee
- b. Technical Committee (divided into 3 teams Alpha, Beta, Charlie)
- c. Information, Education, and Communication Committee
- d. Clean-up Committee
- e. Mangrove Seedling Production Committee; and
- f. Admin & Finance Committee

#### **Accomplished Activities**

#### I. HIRING OF ENUMERATORS

From August to December 2021, twenty-eight (28) enumerators were employed to assist with the implementation of GEM activities. All newly hired went through a thorough selection procedure, including an interview and orientation. In GEM Activities, the Technical Team led by Forester III Ferdinand Gatchalian introduced the usage of

mobile applications like GeoCam and Locus Map. There was also a briefing on the forms to be utilized in the inventory of households and businesses in the target barangays.

## II. CONDUCT OF COMPLIANCE MONITORING ON THE DELINEATED LEGAL EASEMENT AND INVENTORIED AFFECTED ESTABLISHMENTS

From October 27 to November 15, 2021, the team conducted compliance monitoring of establishments issued a Notice to Vacate by the Regional Office for violating PD 1067, often known as the "Water Code of the Philippines," in the Barangays of Poblacion I, II, III, V, VI, and Tagumpay, Coron Palawan.

Due to the COVID-19 Pandemic, several of the establishments issued with NTV have already ceased operations. This office, on the other hand, undertook an inventory of all establishments constructed within Coron Proper (including easement zone and Unclassified Public Forest and Alienable and Disposable of the said barangays). A total of 368 businesses were inventoried, with their current occupation and status identified.

Also conducted inspection and monitoring of all establishments within Coron Proper. This office also contributed personnel to the composite team led by the Department of Interior and Local Government.

## III. INVENTORY OF COMMERCIAL ESTABLISHMENT BUILT WITHIN EASEMENT AND TIMBERLAND/ASSESSMENT OF TENURE

Six (6) of the twelve barangays identified as contributing to Coron Bay's deterioration are being addressed this year (Bintuan, Guadalupe, Lajala. Banuang-daan, Cabuagao, and rest of Tagumpay).

#### **Barangay Bintuan**

On August 19-20, 2021, the team visited Barangay Bintuan and conducted concurrent GEM-related operations, including the delineation of a 40-meter easement (UPF) and inventory of dwellings and enterprises established inside the easement zone. Before taking a break due to the pandemic, the crew built a 40-meter easement zone that stretches for more than 37 kilometres along Barangay Bintuan's coasts and inventoried 139 dwellings in nine sitios.

The inventory of the remaining 64 households in four neighborhoods was finished on September 9, 2021 (including 2 island sitios in Apo Island).

#### Barangay Guadalupe

Barangay Guadalupe was accomplished on September 6, 7, 9, and 15, 2021 where in 211 households were inventoried within the delineated 40m (shore) and 20m (riverbank) easement zones. Two major river is within the political boundary of Barangay Guadalupe namely Calauag River and Bocal bocal River. 36% of the inventoried household's source of income are from Agriculture and Fishery sector.

The team continued its inventory and easement delineation at Uson Island, Barangay Lajala, Coron, Palawan, on September 21, 2021. Since the area/island is still an Unclassified Public Forest, the team demarcated and identified the 3m, 20m, and 40m-easement zones (UPF). A total of 333 households from 9 sitios and 6 puroks (Barangay Proper) in Lajala were interviewed and geotagged (Uson Island). Initially, 30 households have been granted ownership in accordance with Administrative Order No. 1, s. The projected Busuanga Ranching Project was first suggested in 1975 as Busuanga Pasture Reserve.

And from October 14-18, 2021, the group conducted an inventory of homes and businesses built in the 40m clearance area of Barangay Tagumpay. In the easily established area, 298 households with an estimated total population of 1,393 people were interviewed and registered. Agriculture and fishing are the main sources of income for 54% of respondents. After a series of coordinations and meetings with officials of Barangay and the "Apong Dakulo," or Great Elders of the Tagbanua Tribe, the group received permission from DENR to conduct program activities. GEM on November 26, 2021. In the relief area, 87 households were counted in Barangay Banuang Daan and only 3 in Barangay Cabugao. Both bays, located on Coron Island, were issued a Certificate of Ancestral Domain Name Title (CADT) by the National Commission on Indigenous Peoples (NCIP) (CADT No. R04COR0204022) in 2004.

#### I. Clean-Up Drives

Along with GEM restoration and restoration activities, we also conducted twelve (12) cleanup campaigns in selected coastal communities in Coron, Palawan. A total of 762 participants (344 women and 418 men) from different ANGs, LGUs, NGOs and volunteers. A total of 2,720 kg of solid waste and 48 types of medical waste were collected and classified into 5 groups; Mixed plastics, bottles, tins/cans, medical waste and clothing/other waste. Below you will find a summary of the waste collected during the cleaning campaigns carried out. Table 1. Barangays has launched a campaign to clean up and sort the collected waste.

#### ISSUANCE OF NOTICE TO VACATE

Based on the Work and Financial Plan CY 2021 regarding GEM Implementation item C.5., this office shall issue Notice to Vacate to all inventoried establishments and households built within easement zone in 6 target Barangays. This activity has yet to materialize after the conduct of evaluation and assessment of their occupation and this office still need to clarify to the Regional Office regarding to who will issue the said NTV.

#### IV. Mangrove Rehabilitation (Mangrove Seedling Production)

The contract of mangrove seedling production was awarded to Coron Watershed Beneficiary Association-Agroforestry Multi-Purpose Cooperative (CWBA-AMPC). They already accomplished the 100% or 15, 000 pcs of seedlings produced for the planting activities on the following years. Photos below shows the mangrove seedlings produced under GEM.




Figure 9. Photo-documenation of Mangrove Seedling Production

#### V. Sustainability of Island Communities

#### **Information Education and Communication**

Under Item D.2. Meetings/Dialogues, this office conducted several meetings/dialogues with the Local Government Unit (LGU) of Coron, Barangay Local Government Unit of target barangays (BLGUs) and local communities. We also conducted a total of nine (9) Information, Education, and Communication (IEC) Campaigns which focused mainly on the implementation of GEM and some provisions of PD 1067 or Water Code of the Philippines, PD 705 also known as Revised Forestry Code of the Philippines, RA 9003 or Solid Waste Management Act, and Public Land Act. A total of 549 individuals participated the said activities.




Map of the conducted IEC, consultation and interview under the GEM project. Showing the location of inventoried households within the delineated 40m easement zone.


