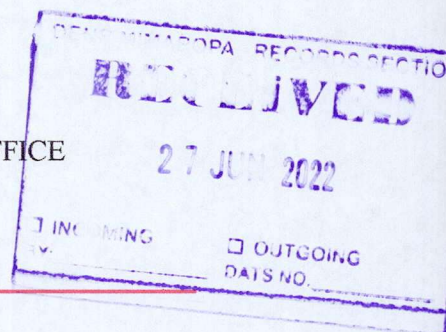

Common instructions on the matter include the submission of the following:


1. Transfer of ownership from listed claimant or CENRO Order dropping the listed claimants.
