ORIENTAL MINDORO**

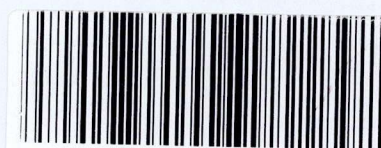
This refers to the technical assistance provided by this Office to different municipalities on the implementation of activities of the Marine Protected Area Network (MPAN) for 2nd quarter of CY 2022.

Based on coordination with the Province's Fishery Sector Head, Ms. Marilyn Alcanices of CD Section Chief Amor D. Asi, a total of 42 MPAs are being managed and protected by the different municipalities under the Office of the Municipal Agriculturist Office (MAO) and Fishery Sector. The activities within these locally-managed MPAs are funded by the concerned municipalities, Malampaya Foundation and Bureau of Fisheries and Aquatic Resources (BFAR). As for the DENR, at present this Office allotted funds for the MPAN meeting, provision of IEC materials and participation in the MPAN activities. Continuous and regular consultation with the MAOs and MENROs are on-going for the provision of technical assistance such as mangrove planting, collection of crown of thorns, law enforcement, participation in the MPAN meeting and IEC.

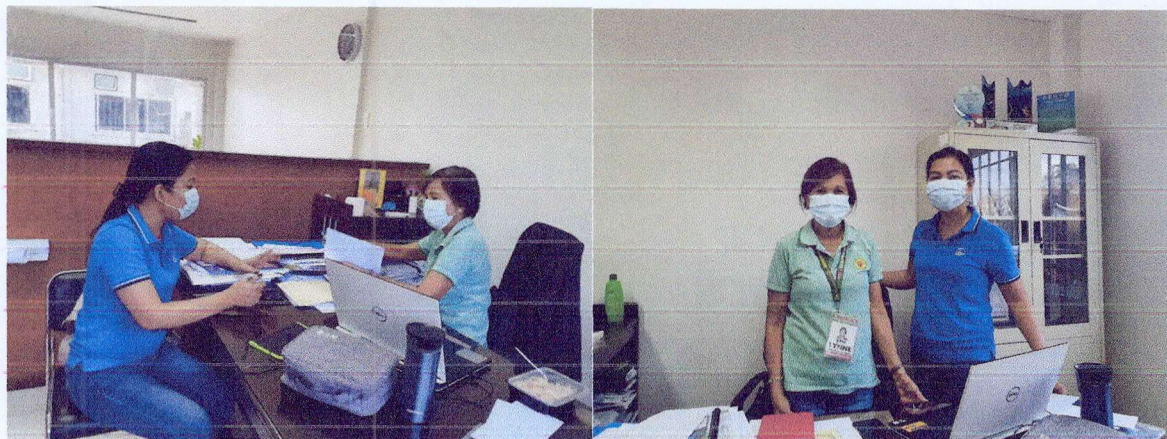

Second Quarter Accomplishment Report CY 2022



Coordination with Ms. Lyn Alcanices, Provincial Government of Oriental Mindoro Fishery Sector Head, regarding activities of MPAN and some information on the implementation of MPAN activities and funding. Likewise, scheduling of this quarter's meeting is set on June 28, 2022 to be funded by the DENR. Based on coordination, a total of 42 MPAs are being managed and protected provincewide.



Discussion of MPA activities with MAO Len Asinas of the municipality of Naujan. This municipality has three (3) locally managed MPAs which include Tujod Fish Sanctuary in Bgy. Herrera, Naujan with a total area of 55 hectares, Masaguig Fish Sanctuary in Bgy. Masaguig with an area of 16 hectares and Buloc-Buloc Cove in Bgy. Montemayor with an area of 72 hectares. These areas are all well-managed by the LGUs, BFAR and DENR.

The municipality also requested to conduct a meeting with their fisherfolks for the IEC on Climate Change Mitigation and Adaptation.
