RESOLUTION

This resolves the Motion for Reconsideration (Motion) filed by appellants Heirs of Clemente Manato, represented by Petra M. Meres and Romeo M. Manato, of the Decision dated 29 January 2015 (Decision) of this Office which dismissed their appeal and affirmed the Decision dated 6 September 2011 and Resolution dated 16 April 2012 of the Department of Environment and Natural Resources (DENR).

After a careful examination of the records, this Office finds no cogent reason to depart from its Decision. The Motion only raises arguments which have already been passed upon by this Office in resolving their appeal.

As the Supreme Court ruled in a plethora of cases, a motion for reconsideration that does not make out any new matter sufficiently persuasive to induce modification of judgment should be denied.¹


WHEREFORE, in view of the foregoing, the Motion is hereby **DENIED**.
