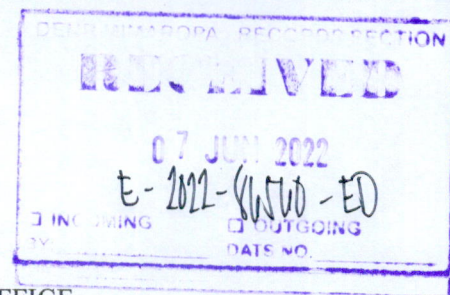



This pertains to the Memorandum dated May 4, 2022 of Merlinda Manila, Head, DENR Action Center/Hotline addressed directly to your end sent via email on May 5, 2022 with the accompanying letter complaint dated January 28, 2022 from Mr. John Paul Reyes and Ms. Vanessa Reyes seeking assistance to investigate the land claimed by Mr. Benito Marcelo, Jr.

In the said letter, Mr. and Ms. Reyes claimed that their grandparents have been occupying and cultivating the lot claimed by Mr. Marcelo since 1956 and allegedly after 15 years Mr. Marcelo tried to grab/seize said parcel of land by presenting to them the Original Certificate of Title No. G-643. Accordingly, said OCT did not exist when verified at the Registry of Deeds-Puerto Princesa City and Land Management Bureau. It was also stated in the letter that the parcel of land was awarded to their grandfather on March 10, 1971 by the Department of Agriculture and Natural Resources.

In this regard, you are hereby directed to conduct investigation and verify the veracity of the allegations in coordination with the concerned party/ies. Take appropriate action consistent with existing laws, rules and regulations. Further, submit report in CSW format within seven (7) days with comment/s and categorical recommendations.
