


PRIMARY PURPOSE

To explore, develop, mine, operate, produce, utilize, process and dispose of all the minerals and products and by-products that may be produced, extracted, gathered, recovered, unearthered, or found within Sitio Ipilan, Mambalot, Municipality of Brooke's Point, Province of Palawan, consisting of 2,835.06 hectares and covered by Mineral Production Sharing Agreement (MPSA) No. 017-93-IV granted on August 5, 1993 by the Government of the Republic of the Philippines through the Secretary of the Department of Natural Resources.

SECONDARY PURPOSE

1. To purchase, acquire, own, lease, sell and convey real properties such as buildings, factories and warehouses and machineries, equipment and other personal properties as may be necessary or incidental to the conduct of the corporate business, and to pay in cash, shares of its capital stock, debentures and other evidences of indebtedness, or other securities, as may be deemed




