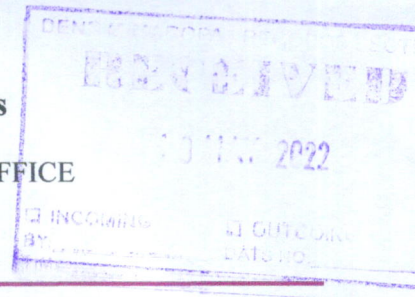

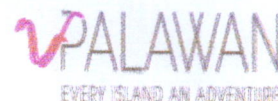

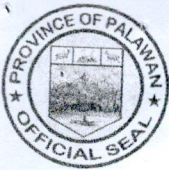

WHEREAS, the Local Government Code of 1991 expressly provides that all Local Government Units shall ensure public safety and protect the general welfare of its constituents and provide basic social services that they need;

WHEREAS, on December 16, 2021, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), issued Weather Bulletin No. 11 forecasting intensified direction and movement of typhoon *Odette* in the Philippines and made its landfall over the coastal waters of Cuyo and other parts of Palawan on December 17, 2021 at 11:00AM, causing severe damages to properties, public infrastructures, crops also disrupting delivery of services of public utilities and communications;

WHEREAS, Executive Order No. 90, series of 2021 entitled, "An Executive Order Providing or Establishing the Structure of the Palawan Provincial Disaster Risk Reduction and Management Council Emergency Operations Center for Typhoon *Odette*" was created to monitor the prevailing weather disturbance, situation updates, and to respond to the needs of the typhoon *Odette* victims;

WHEREAS, the Provincial Government of Palawan is grateful for the continued support and contribution of various agencies in the conduct of Emergency Response Operations during and after the typhoon;

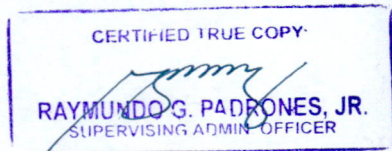
