



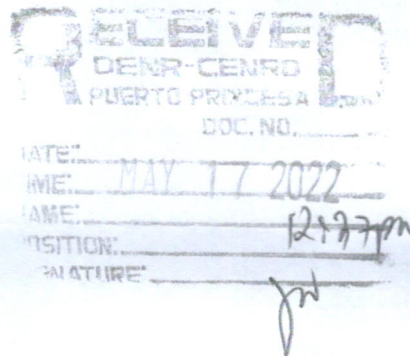

RESOLUTION NO. 09 - SERIES OF 2022

A RESOLUTION REITERATING THE COOPS' EARLIER REQUEST TO THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER (CENRO), PUERTO PRINCESA CITY, PALAWAN, TO HOLD THE MULTI-SECTORAL ACTIVITY WORKSHOP SO THAT THE PROGRAMS AND PROJECTS INCLUDED IN THE COMMUNITY RESOURCES MANAGEMENT FRAMEWORK (CRMF) AND WORK PLAN OF NAGSAGUIPI-CALATUBOG FARMERS MARKETING COOPERATIVE (NCFMC) CAN BE ASSESSED AND EVALUATED AND THE COOPS' APPLICATION FOR THE RENEWAL OF THE CBFM AGREEMENT CAN BE PROCESSED.

WHEREAS, NAGSAGUIPI-CALATUBOG FARMERS MARKETING COOPERATIVE has submitted to the CENR-Office, Puerto Princesa City, Palawan on October 29, 2020 the necessary documents for the affirmation of its CRMF, with the hope that after its approval, the application for the renewal of the CBFM Agreement may be filed.

WHEREAS, again, on November 16, 2020, NAGSAGUIPI-CALATUBOG FARMERS MARKETING COOPERATIVE has submitted to the CENR-Office, Puerto Princesa City, Palawan a follow-up letter for the affirmation of the Revised CRMF and Five (5) Year Work Plan with hope that the same be approved and incorporated in our request for the renewal of our CBFM Agreement with the DENR.

WHEREAS, on December 14, 2020, the CENR Office sent a letter-reply to NAGSAGUIPI-CALATUBOG FARMERS MARKETING COOPERATIVE informing the coop that the updating of the coops' CRMF is a multi-sectoral activity workshop which requires the presence of different government agencies during the activity, setting the 1st quarter of the year 2021 as the scheduled date for the; 1) Training of DENROS or Environmental Officers and 2) Workshop for the updating of CRMF.

WHEREAS, after a year passed by and on February 14, 2022, **NAGSAGUIPI-CALATUBOG FARMERS MARKETING COOPERATIVE** sent a letter to the CENR Office, P.P.C., copy furnished the office of PENRO, Palawan and DENR REGION IV-B, MIMAROPA, requesting for the holding of the multi-sectoral workshop be held, but unfortunately, no response was sent to the coop until this date.

WHEREAS, with time running out for the submission of the necessary requirements for the renewal of the coops' CBFM Agreement with the DENR Region IV-B, MIMAROPA, this resolution is of utmost necessity.


NOW THEREFORE, upon motion of **BOD FELIX T. PAEZ**, and duly seconded by the majority of the members of the Board of Directors, be it;

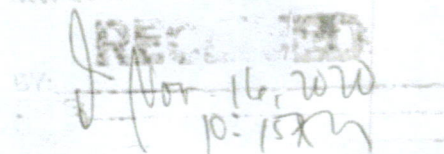
This is to follow-up the cooperatives' request for Affirmation of the revised CRMF and Five (5) year Work Plan submitted to your office last October 29, 2020.
