**SUBJECT :** ADMINISTRATIVE ADJUDICATION OF APPREHENDED UNDOCUMENTED FINISHED AND SEMI-FINISHED FOREST PRODUCTS LOADED IN A BLACK WITH BLUE AND BLACK COLOR KAWASAKI (BARAKO) MOTORCYCLES WITH TOPDOWNS OWNED BY MR. EDRIAN D. EGANA AND MR. NOLI D. EGANA RESPECTIVELY

Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated April 28, 2022 relative the above subject.

Per memorandum, the apprehension was made on June 8, 2019, around 11:45 P.M. at South National Highway, Barangay Sicsican, Puerto Princesa City, Palawan by the elements of Puerto Princesa City Night Patrol Anti-Crime Task Force while doing patrol works. The team apprehended two (2) Units of Motorcycles with Top downs loaded with furniture without transport documents and thereafter properly turned-over the apprehended items to CENRO Puerto Princesa for safekeeping and proper disposition.

The team apprehended the vehicles specified first as one (1) Unit Black with Blue Color KAWASAKI (Barako) Motorcycle with Top down, no Plate Number, loaded with Sala Set & Dining Table made from Mahogany Lumbers with estimated fair market value of Php50,000.00 & Php16,000.00 respectively and driven by Mr. Edrian D. Egana. The second vehicle described as one (1) Unit Black Color KAWASAKI (Barako) Motorcycle with Top down, bearing Plate Number DD 22478, loaded with Bed & Sofa Bed made from Mixed Mahogany, Malugai & Sakot/Saket Lumbers with estimated fair market value of Php50,000.00 & Php25,000.00 respectively and driven by Mr. Noli D. Egana. Both Egana are residents of Barangay Luzviminda, Puerto Princesa City, Palawan.

Notices of hearings were sent to the respondents and apprehending Officers and the hearings were conducted on July 3, 2019 at 10:00 A.M., July 11, 2019 at 2:00 P.M and July 12, 2019 at 1:00 P.M. respectively.

Further, Mr. Edrian D. Egana submitted the Affidavit of Undertaking duly notarized on March 31, 2022 and letter request with attached photo copy of Official Receipt and Certificate of Registration of his vehicle received on April 18, 2022. Furthermore, in support to Mr. Edrian D. Egana's claims, Mr. Nilo L. Tinasas make an Affidavit duly notarized on July 13, 2019.

Other documents presented and enclosed in the memorandum are the following:

1. Certificate of Tree Plantation Ownership No. PPC-045316-2019-002 dated January 4, 2019 and Certificate of Registration of Tree Plantation(s) in Private Land(s) dated January 24, 2019, both issued to Co-Owner's Ms. Astred and Nilo L. Tinasas.

2. Official Receipt Numbers 005914 & 005915, dated June 8, 2019 & June 9, 2019 respectively. Both OR amounted to Php320.00 each and payments received from Mr. Eric Patigdas.

In view of the above, we concur with CENRO recommendations that the Black with Blue Color of KAWASAKI Motorcycle with Top down, no plate number, be temporarily released after due clearance from the Office of Regional Executive Director as per Memorandum and compliance to the required documents such as Letter Request, Memorandum of Understanding, Appraisal, Posting of Bond and others. While the other apprehended Black Color KAWASAKI Motorcycle with Top down bearing Plate Number DD 22478 loaded with mixed species be confiscated in favor of the government and a criminal complaint be filed before the City Prosecutor's Office against Mr. Noli D. Egana for violation of Section 77 of Presidential Decree No. 705, as amended.
