This refers to the approval of appraisal over a foreshore lot covered by Foreshore Lease Application (FLA) No. 044003-135-2008 of Zenaida L. Bayot, located in Brgy. Bachao-Ibaba, Gasan, Marinduque, for resort/eco-tourism purposes.

Upon review and evaluation, we find the recommended appraisal of the land to be fair and in accordance with DAO No. 98-20, as amended by DAO No. 2010-26 and other existing laws, rules and regulations. However, we have noticed that the competent evidence of identity of the applicant was not attached to the folder.

In view of the issuance of DENR Administrative Order (DAO) No. 2022-07<sup>1</sup> dated March 23, 2022, delegating the approval of appraisal/re-appraisal reports on foreshore lands, SAPA, and other patrimonial properties of the State to the Regional Executive Director (RED), we are returning the complete folder of the FLA of Zenaida L. Bayot, for your appropriate action.

Moreover, please be reminded that the following documents should also be secured prior to the issuance of Order of Award and Lease Contract:

a. Comment and recommendation of the District/City Engineer, DPWH with the concurrence of the Regional Director of DPWH;

b. Comment and recommendation of the Local Port Authority concerned and/or concurrence of the General Manager of PPA;

c. Comment and recommendation of the Department of Tourism; and

d. Environmental Compliance Certificate (ECC) or Certificate of Non-Coverage (CNC).

Also, kindly furnish this office and the Office of the Undersecretary for Legal, Administration, Human Resources and Legislative Affairs of the action taken thereon for reference.


