REQUEST FOR ASSISTANCE OF A GEODETIC ENGINEER **CONDUCT** SURVEY ON **EASEMENT** DEMARCATION IN OTHER COASTAL MUNICIPALITIES WITHIN THE PROVINCE AND RELOCATION SURVEY OF BOUNDARY OF SAN RAFAEL CAVE, ROXAS, ORIENTAL

**MINDORO** 

This refers to the Memorandum dated May 10, 2022 from CENR Officer Caesar E. Quebec, CENRO Roxas, Oriental Mindoro, requesting for a Geodetic Engineer to conduct survey on easement zone demarcation along coastal areas of Pili, Pinamalayan, Oriental Mindoro and boundary disputes of San Rafael Cave, San Rafael, Roxas, Oriental Mindoro.

It may be recalled that the Municipal Mayor of Mansalay, Oriental Mindoro also requested for an easement survey along shoreline of Sitio Balanga, Barangay B. Del Mundo, Mansalay as per Resolution No. 2022-723 dated March 8, 2022 which was already forwarded to the Regional Office. Furthermore, commercial establishments in other coastal municipalities within the province also requested for the issuance of certificate of easement compliance necessary for the renewal of their business permits, however, no demarcation of easement yet was conducted, except Puerto Galera, hence we could not act on request. In addition, there were complaints regarding illegal occupation onto the easements zone in Pili, Pinamalayan, which could be properly address when easements were already demarcated and dileneated.

In this regard, may we reiterate our request for assistance in the conduct of easement zone demarcation in other coastal municipalities within the province to address the needs of the commercial establishments and to clarify the complaints on illegal occupation on easement area, and for the conduct of relocation survey of boundary of San Rafael Cave for possible resolution of boundary disputes.



I'm seeking for resolution on this matter, I attached recent photos as well. Please Do not hesitate to contact me via email if you have any concerns or comments.


I'm also giving my full authority to Lucita Garcia to be my representative when needed a proxy for any dialogue.
