This has reference to our Memorandum dated 07 April 2022, inviting the DENR Regional Offices for the conduct of face-to-face Cluster training on the use of Water Quality Checkers cum consultation workshop scheduled on July-August 2022.

As of this writing, there are seven (7) out of the fifteen (15) regional offices that have completely registered for the training (Region I, II, III, IV-A, XII, CARAGA, and NCR), while four (4) regional offices have exceeded the allotted number of participants (Region IV-B, V, VI, and VIII). On the other hand, the remaining four (4) regions have not filled up/completed their registration yet (DENR VII, IX, X, and XI).

In line with this, we would like to reiterate our request for the participation of the concerned staff from your respective regions, to wit:

- Two (2) representatives from the Protected Area Management Office (PAMO)/field office concerned who are closely working on the conduct of water quality monitoring within NIPAS MPA; and
- One (1) representative from the Conservation and Development Division through the Coastal Resource and Foreshore Management Section.

For those regions who have not registered yet or with remaining available slots, the select participants are still required to register through this link: https://tinyurl.com/WOMTrainingWorkshop. As mentioned above, please take note of the required number of participants from your respective regions. The extended deadline for registration is on or before 31 May 2022.

On the other hand, we advise the regional offices with exceeding numbers of participants to stick with the required number of participants per Office, and confirm with us your priority/final list of attendees. Moreover, please be informed that due to the unavailability of the product specialist of the winning bidder on 18-22 July 2022, the Cluster II training has been moved to 25-29 July 2022.

Lastly, in order to optimize the time and financial expenses, the roll-out of the approved Technical Bulletin in *Mainstreaming the Integrated Coastal Management (ICM)* Approach into the Comprehensive Land Use Plan (CLUP) shall be backed-to-backed during Cluster 1 training scheduled on July 11-15, 2022. With this, the training shall be extended until July 16, 2022 to facilitate the roll-out of the approved policy. Attached herewith is the revised provisional program of activities for the Cluster I training cum consultation workshop.

The schedules for the Visayas and Mindanao clusters, as well as the details of the ICM roll-out, are still for finalization and shall be provided to the concerned Regions in a separate memorandum.
