

Sir/Maam:

This is in connection to the attached memorandum (Annex A) dated February 20, 2006 pertaining to the investigation on the conflict in the area and claimed/titled to Mr. Allan Pe and on areas covered with the Certificate of Stewardship Contracts (CSCs) granted to us by DENR in Bgy. Babuyan, Puerto Princesa City.

As pointed out in that investigation report, our respective CSCs are fully developed and planted with different crops serving as our main source of livelihood. Recently, a billboard for a farm to market road (Annex B) in this area was placed/installed giving us hope to ease transport of farm products, but accordingly Mr. Pe opposed and prevented the construction of this farm to market road, sadly depriving us of this much needed infrastructure. The said billboard has since been missing and nowhere to be found.

We have been in this area long before the CSCs were issued and barangay officials can vouched on this. It was surprising how Mr. Allan Tan Pe or his predecessors have acquired title (Annex C) to this area when publicly we know its status is timberland, hence CSCs were issued to us.

With the foregoing, may we be apprise what course of action the DENR took in that investigation report? Moreover, may we also be informed officially whether the conflict/disputed area with Mr. Pe is alienable or disposable land to warrant its titling. If in the negative, perhaps the DENR is the authority to commence cancellation proceedings of that title.

We will appreciate very much to receive a reply on our query and immediate resolution of this conflict to diffuse tension in this area. Thank you.

Last February 7, 2006 the group of DENR-CENRO personnel under the FMS Unit headed by Chief FMS proceeded to Barangay Babuyan conducted meeting and actual inspection/investigation in the area.

The meeting was presided by Chief FMS Conrado Corpuz and were attended by the Barangay Chairman and their Kagawad and other old folks who residing in that place long time ago.

During the meeting there are some person testifying on their own knowledge and observation especially on that certain area.

Here are the following presentation observation and findings to wit:

- 1. For Corpuz presented and show the relocation map of the title lot of Mr. Allan Fe and the CSC maps of the CSC holders of Mr. George Cayao et. al.
- 2. Barangay Kagawad Hernando Roca Sr. Pointing out on the map that the land title of Mr. Allan Fe is in the right side only when we are going north.
- 3. Kagawad Antonio de los Santos said that the application of Luz Toribio is not big as that of 7.6 has. Because it is timberland.
- 4 Nellie Favila Heirs of Sofronio Favila (deceased) CSC holder explain that as far as she know the title of Mr. Allan Fe is only 7.1 has. further informed also that the title no. of that land is 1141 which accordingly same no. of title lot of Mr. Allan Fe is same no. of his two lots located at Barangay Sta. Lourdes and Barangay Bacungan. She ask also if is that possible. She said that because she had research from the Register of Deeds. She has also a copy of verification from the LC survey before thru Mr. Art Palatino.

Her question was answered no that it is not possible that the title lot have the same no. with that area located at different barangays.

She declare also that all planted forest trees and fruit trees wereplanted by the CSC holders since the start of CTF in 1979 and awarded to them in 1983.

5. Other folks told as also that they did not even know and saw that certain Toribio she did appeared on that placed especially on that Barangay.

After the meeting the group, Barangay officials and CSC holders proceeded to the area for inspection.




