

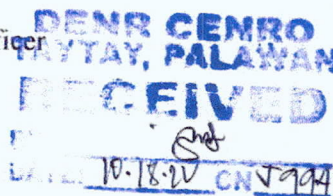

SUBJECT : **REPORT ON CONDUCTED INFORMATION, EDUCATION, AND COMMUNICATION (IEC) ACTIVITY IN BARANGAY TENEGUIBAN AND SAN FERNANDO, EL NIDO, PALAWAN**



In connection with the implementation of Green Economy Model (GEM) El Nido and to strengthen the awareness of community on DENR services, please be informed that the undersigned together with Forest Rangers Jonathan Arzaga, Herson Caliao, John Gil Lagrana, and Francis Jade Cometa from Mines and Geosciences Bureau (MGB) conducted Information, Education, and Communication (IEC) Campaign in two barangays in El Nido, Palawan. Morning session was held at Barangay Teneguiban while afternoon session was held at Barangay San Fernando.

The team discussed the salient provisions of Presidential Decree 705 or the Revised Forestry Code, the Republic Act No. 9175 or Chainsaw Act, the tenurial instrument issued within protected areas and forestlands, processing of land titling, Presidential Decree 1067 or the Water Code and salient features of Republic Act No. 7942 or the Mining Act of 1995.



Issues and Concerns

Most of the issues and concern raised in Barangay Teneguiban during Open Forum were regarding (1) reclassification of timberlands into agricultural lands so that the majority who currently occupying timberlands can apply for title; (2) tax declaration issued to timberland occupants; (3) allowable easement on seashore and river; and (4) rights of Indigenous People (IPs) on the ancestral land.

As to Barangay San Fernando, issues and concerns of the barangay and residents were about (1) result of the assessment of Certificate of Stewardship Contracts; (2) status of claims and conflict of Iteralde against Rey; and (3) allowable easement.

All these issues and concerns has been properly addressed by the team led by DMO IV Lilang.

The participants composed of barangay officials and residents. A total of 116 individuals of which 68 female and 48 male participated. Ten (10) individuals received different collaterals such as t-shirts, eco tote bag and ballpens with Tayo Ang Kalikasan (TAK) logo during the Q and A portion of the activity.


One remarkable outcome of the conducted IEC was preference of Barangay San Fernando for the implementation of same program and activity as of Green Economy Model in their barangay.
