Respectfully forwarded is the memorandum of CENRO Brooke's Point, Palawan dated October 20, 2022 relative the above subject.

Per memorandum, the apprehension was made on May 30, 2022 at around 4:00 A.M. while the personnel of PNP Brooke's Point Municipal Police Station, Palawan PPO PIU and PDEU conducting a joint operation in response to the received information by PNP Brooke's Point MPS concerning the alleged violation of Section 77 of PD 705 at So. Suring II, Barangay Pangobilian, Brooke's Point, Palawan.

The team intercepted/apprehended the one (1) unit motorcycle Barako II without plate number (Chassis No. 175H-B85306) with sidecar or topdown loaded with twenty-five (25) pieces lumbers of Agas species with a total volume of 252 board feet. The estimated fair market value of vehicle is Php75,000.00 while the Agas lumber is Php12,600.00.

The said apprehended items were recovered in the possession and control of Mr. Kris Apenio Masong (Mr. Cres Bebas Arpenio), a driver and a resident of Barangay Imulnod, Brooke's Point, Palawan. All the apprehended items were brought to PNP Brooke's Point Municipal Police Station Compound under the custody of PCpl Brynner S. Sobebe, Investigator for safekeeping purposes.


Notices of hearings were sent to all concerned parties and the administrative hearing was conducted on August 02, 2022 at the Office of CENRO Brooke's Point, M. Rodriguez St. Poblacion District I, Brooke's Point, Palawan in relation to Item No. 1 & 2, Section 7 of DAO 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product and conveyance.

Submitted herewith is the minutes of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on August 2, 2022 at CENRO Brooke's Point, Palawan.

#### I. **FACTS OF THE CASE**

The apprehension was made by personnel of PNP Brooke's Point Municipal Police Station, Pal PPO PIU and PDEU at about 4:00 in the morning of May 30, 2022 during the conduct of a joint operation in response to the information received by PNP Brooke's Point MPS concerning the alleged violation of Section 77 (formerly Section 68) of PD 705 at Sitio Suring II, Barangay Pangobilian, Brooke's Point, Palawan.

The one (1) unit motorcycle Barako II without plate number (Chassis No. BC 175H-B85306) with sidecar (topdown) loaded with twenty-five (25) pieces lumbers of Agas species having a total volume of 252 board feet had been intercepted/apprehended without pertinent documents from the DENR. Said apprehended items were recovered in the possession and control of Mr. Kris Apenio Masong (Mr. Cres Bebas Arpenio) - driver, a resident of Barangay Imulnod, Brooke's Point, Palawan. The apprehended items were now dep osited at PNP Brooke's Point Municipal Police Station compound under the custody of PCpl Brynner S. Sobebe, Investigator for safekeeping purposes.

#### II. STATEMENTS OF PARTIES INVOLVED DURING THE HEARING PROCESS

The Apprehending Officers were unable to attend the scheduled Administrative Hearing: hence, for information of the apprehended person (Mr. Kris Apenio Masong), the Hearing Officer read the affidavit submitted by Patrolman Cliford John Q. Lapore of PNP Brooke's Point Municipal Police Station in which he testified that in response to the information relayed to their station by an informant thru phone call at more or less 4 o' clock in the morning (4:00 AM) concerning the alleged illegal transport of wood materials (kahoy), their OIC, Police Lieutenant Norzealito R. Avanceña immediately coordinated with the personnel from PIU Palawan PPO headed by PCMS Ruzel Briones and personnel of PDEU Palawan PPO currently assigned at Brooke's Point, Palawan to verify/confirm the said information. At around 4:20 AM, PSSg Rodney Sagala of PDEU notified them that they had intercepted an individual onboard one (1) unit topdown loaded with newly cut/sawn lumbers at So. Suring, Barangay Pangobilian, Brooke's Point, Palawan. Accordingly, Patrolman Lapore together with PSSg Elmo Caabay and PCpl Brynner S. Sobebe (investigator) were then dispatched in the area. On-site, the team met PCMS Briones and PCpl Marcel Felix both from PIU and PSSg Sagala as well as the driver of the one (1) unit topdown loaded with lumbers later identified as Mr. Kris Apenio Masong - a resident of Barangay Imulnod, Brooke's Point, Palawan.

During on-site investigation, Mr. Masong failed to present any documents/permit required for the possession and transport of the lumbers. Consequently, PCpl Sobebe arrested him for violation of Section 68 of PD 705 and recited and explained the Miranda Doctrine and Anti-Torture Law. Meanwhile, the one (1) unit topdown including the lumbers were apprehended. For safety purposes, the apprehending officers decided to conduct the inventory of apprehended lumbers at PNP station. Upon inventory, Patrolman Lapore provided certification of apprehended/confiscated evidences from Mr. Masong to their investigator. Patrolman Lapore added that they were unable to gather video of the arrest of the perpetrator and other documentation of the operation; since currently there is no PNP issued Body Worn Camera (BWC) to Brooke's Point MPS. Likewise, considering that the operation is abrupt/sudden they were unable to Request for Ex Parte from the Court.

On the other hand, based on the inventory conducted by the personnel of CENRO Brooke's Point, the apprehended items included one (1) unit motorcycle Barako II black in color with red with sidecar (topdown) without plate number and Agas lumbers with different sizes/dimensions having a total volume of 252 board feet.

Note: The respondents affirmed to voluntary give their statements without the presence of a lawyer or legal counsel.

In the same hearing, the apprehended person stated that his name is Cres Bebas Arpenio and not Kris Apenio Masong. He is 42 years old born on October 9, 1979 and works as laborer in a daily basis (nag-aarawan sa mga tao). Mr. Arpenio narrated that on May 30, 2022 at more or less 4:00 in the morning, he was apprehended/intercepted while transporting 25 pieces of Agas lumbers without pertinent documents/permit. Mr. Arpenio claimed that he was already desperate for lack of/no source of food for his family so he decided to transport the said lumbers before daybreak (madaling-araw). Accordingly, the undersigned probed if he knows that it is illegal to transport lumbers as he tried doing so before daybreak to which Mr. Arpenio answered "yes". However, Mr. Arpenio also claimed that he is unaware that permit/s is required for the transport of lumbers. Mr. Arpenio further claimed that the lumbers were to be delivered in exchange of rice grains (palay) to some Ilocano in So. Suring whose name he is unaware of. He added that

said lumbers which he exchanged with chicken and originally intended for the construction/repair of their house were sourced out and sawn from the mountain by some outsiders (dayo). Mr. Arpenio said that he owns the apprehended conveyance and submitted the corresponding documents/papers of the motorcycle on August 4, 2022. Mr. Arpenio also asked/appealed that hopefully the motorcycle can be released as they have nothing to use to load vegetables and added that the same is still being paid in an installment basis.

Also in the same hearing, Mrs. Reina T. Arpenio, Mr. Cres Bebas Arpenio's wife mentioned that Mr. Arpenio's sister called her up to inform her about the apprehension thus she went to the Police Station wherein they were told to just wait for what will be done to Mr. Arpenio. Mrs. Arpenio added that she talked with the police to request if the motorcycle can be released. She also mentioned that they are already planning to turn-over the same to someone else (ipasalo) as they no longer know where to get help and they likewise have no money to buy food. Mrs. Arpenio stated that the apprehended motorcycle is registered under her name. She also admitted that she knew that her husband will transport the lumbers without pertinent documents/permit and claimed that she did not oppose/stop him from doing so as they no longer have a choice because their family has already nothing to eat/no source of food. She also claimed that she does not know that in case of apprehension due to transport of lumbers without pertinent documents/permit the conveyance involved will also be apprehended/confiscated. Further, Mrs. Arpenio also appealed/requested if the conveyance can be released as they utilized the same for their source of livelihood/income, service and loading/transporting of vegetables.

Mr. Bagong Bebas, Mr. Arpenio's uncle also attended the hearing to prove/support that Mr. Arpenio transported the lumbers to exchange for rice grains (palay).

#### III. FINDINGS/EVALUATION

The possession and transport of forest products - 25 pieces of lumbers of Agas species onboard one (1) unit motorcycle Barako II without plate number (Chassis No. BC 175H-B85306) with sidecar (topdown) are not covered by appropriate DENR documents/permits; hence, a patent violation of Section 77 of PD 705 as further amended.

In view of the facts presented, it was found out that there were sufficient and convincing evidences to support the finding of probable cause to charge **MR. CRES BEBAS ARPENIO** of violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

#### IV. RECOMMENDATION

In view of the above findings and evaluation, it is recommended that the forest products and conveyance – twenty-five (25) pieces of lumbers of Agas species with a total volume of 252 board feet and one (1) unit motorcycle Barako II without plate number (Chassis No. BC 175H-B85306) with sidecar (topdown) be confiscated in favor of the government in addition to the appropriate charges filed by PNP Brooke's Point Municipal Police Station against Mr. Cres Bebas Arpenio for violation of Section 77 (formerly Section 68) of PD 705 as further amended by E.O. 277 and R.A. 7161.



Cres Bebas Arpenio: Nag-aarawan lang sa mga tao.

Hearing Officer: Birthday?

Cres Bebas Arpenio: October 9, 1979.

Hearing Officer: Ilang taon ka na ngayon?

Cres Bebas Arpenio: 42 po sir.

Hearing Officer: Una kong tanong sayo, nasaan ka noong Mayo 30, 2022, humigit kumulang alas kwatro ng madaling

araw?

Cres Bebas Arpenio: Yan na po yung pagkahuli sa akin po sir.

Hearing Officer: Bakit ka hinuli?

Cres Bebas Arpenio: May dala po akong kahoy sir.

Hearing Officer: Ilang pirasong kahoy ang dala mo?

Cres Bebas Arpenio: Twenty-five (25) piraso po sir.

Hearing Officer: Anong klaseng kahoy ito?

Hearing Officer: Yung pagkakarga o pagbibiyahe ng kahoy, alam mo na nangangailangan ito ng permit?

Cres Bebas Arpenio: Hindi po sir.

Hearing Officer: Gaano na katagal na itong mga kahoy naka-stock sayo?

Cres Bebas Arpenio: Bago lang yan sir.

Hearing Officer: Yung sasakyan na kinargahan mo, kanino ito?

Cres Bebas Arpenio: Akin po sir.

Cres Bebas Arpenio: Opo sir.

Hearing Officer: Doon sa pagbiyahe mo, meron ka pa bang ibang kasama?

Cres Bebas Arpenio: Wala po sir ako lang.

Hearing Officer: Sino ang mga kumumpiska sayo? Anong otoridad yun?

Cres Bebas Arpenio: Police po sir.

Hearing Officer: Pagkatapos kang masita doon sa Suring II at napuntahan ka ng PNP, ano ang sumunod na pangyayari?

Cres Bebas Arpenio: Dinala po ako sa Police Station.

Hearing Officer: Anong ginawa doon at anong nangyari doon?

Hearing Officer: Gaano ka katagal doon sa himpilan ng pulisya?

Cres Bebas Arpenio: Isang araw po sir.

Hearing Officer: Uulitin ko, yung pagbiyahe mo ng kahoy ay walang permit?

Cres Bebas Arpenio: Opo sir

Hearing Officer: Yung sasakyan noong sinita ay wala ka rin dalang kaukulang papeles?

Hearing Officer: Kayo po, magbibigyan kayo ng statement patungkol dito?

Reina T. Arpenio: Opo sir.

**Hearing Officer**: For record, pakibanggit ang iyong buong pangalan, edad, trabaho, saan nakatira at iba pang bagay na maaaring pagkakilanlan sa iyong pagkatao.

**Reina T. Arpenio**: Ako po si Reina Arpenio, nakatira sa Barangay Imulnod, Brooke's Point, Palawan. Ang trabaho ko po arawan po sir, kung may magpaarawan kung wala, wala din po sir.

Hearing Officer: Bakit ka nandito ngayong umaga?

Reina T. Arpenio: Asawa po ako ni Cres Arpenio.

**Hearing Officer**: Ang tanong ko sayo, anong nalalaman mo dito sa pagkumpiska o pagkahuli ng iyong asawa noong May 30, 2022?

**Reina T. Arpenio**: Tinawagan po nila ako na nahuli nga po siya, tapos bumaba po ako at sumunod po ako sa kanya, wala na rin po kaming makain.

Hearing Officer: Tinawagan ka?

Reina T. Arpenio: Opo.

Hearing Officer: Sinong tumawag sayo?

Reina T. Arpenio: Yung ate niya po.

Hearing Officer: Saan ka pumunta?

Reina T. Arpenio: Diyan nap o sa Police Station.

Hearing Officer: Ano naman ang ginawa niyo doon?

Reina T. Arpenio: Wala na rin po, hintayin lang daw namin kung anong gawain sa kanya.

Hearing Officer: Pagkatapos niyo doon sa istasyon ng pulisya, ano pa yung mga sumunod na nangyari?

Reina T. Arpenio: Wala na rin po sir.

Hearing Officer: Nagbigay ka ba ng statement doon sa police?

**Reina T. Arpenio**: Kinausap ko po yung police na kung pwede yung motor ilabas, ipapasalo na nga po sana namin kasi wala na po makuhanan ng tulong, wala na rin kaming pambili namin ng pagkain.

Hearing Officer: Yung pagkakarga ba niya ng kahov alam mo?

Reina T. Arpenio: Opo.



1. What: Violation of Section 68 of P.D. 705

2. Where: Sitio Suring II, Barangay Pangobilian, Brooke's Point, Palawan.

3. When: May 30, 2022, 2022 at about 4:29 AM return to the station at about 5:18 AM.

4. Who: **Kris Apenio Masong**, male, 40 years old, married, farmer and a residents of Barangay Imulnod, Brooke's Point, Palawan.

5. How/Why: At about 4:00 AM on May 30, 2022 information was received from a confidential informant on an alleged violation of Sec.68 of P.D. 705 at Sitio Suring II Barangay Pangobilian, Brooke's Point, Palawan. Immediately a joint operation was conducted by this station together with the personnel of Pal PPO PIU and PDEU. Upon approaching the Barangay Road near the compound of the Olbinado family, they saw a top-down, loaded with fresh-cut lumbers. Upon seeing the operating team the driver tried to escape but the operating team able to held the suspect and asked for the pertinent document but failed to present the same. Suspect identified as Kris Apenio Masong, male, 40 years old, married, farmer and resident of Brgy. Imulnod, Brooke's Point, Palawan. The operating team returned to the station at about 5:18 AM of this date together with the confiscated evidence to wit; One (top-down) Barako II 175 4-stroke, color black with red with chassis number BC 175H-B85396, no plate no attached, and 25 pcs assorted fresh-cut sawn lumbers (alleged Aga's tree". IOC requested assistance from DENR for proper measurement of the confiscated lumbers. A case for the violation of Sec. 68 of the P.D. 705 was prepared against the suspect. IOC PCpl Sobebe, CP no. 09675175308.

- 6. Recommendation:
  - a. The apprehending team recommends that a legal action be applied for the perpetrator corresponding to the offense committed.
  - b. The items apprehended should be subjected for administrative confiscation proceedings for forfeiture and disposition.
