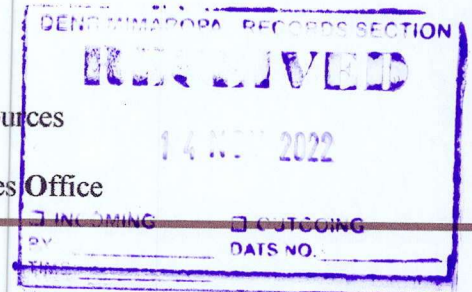

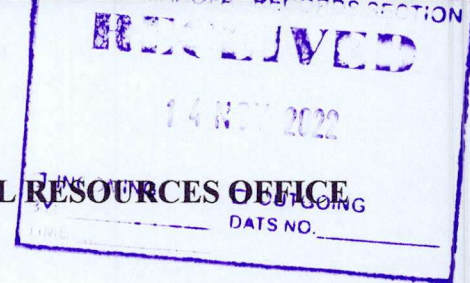

SUBJECT : INSPECTION AND MONITORING REPORT ON THE CEASE AND DESIST ORDER (CDO) ISSUED TO MR. MARIANITO PADILLA FOR THE ALLEGED ILLEGAL BEACH SAND EXTRACTION AT AROMA BEACH, BARANGAY SAN ROQUE, MUNICIPALITY OF SAN JOSE, OCCIDENTAL MINDORO

This has reference to the Memorandum dated 24 May 2021 from the Mines and Geosciences Bureau MIMAROPA Region requesting for the conduct of a Quarterly Monitoring/Inventory of the CDOs issued by this Office and/or the MGB MIMAROPA.

In Occidental Mindoro, the MGB MIMAROPA issued a CDO dated 24 May 2022 to Mr. Marianito Padilla, a resident of Poblacion III, Municipality of San Jose. This Office confirmed on 08 April 2022 that Mr. Padilla conducted illegal beach sand extraction at Aroma Beach in Barangay San Roque, San Jose. He was then informed of the said violation and ordered him to immediately cease and desist from further conducting the said illegal activity.

In view of the above, the undersigned, accompanied by Forest Technician Loren Kaye Garcia of CENRO San Jose, conducted the monitoring on 14 October 2022. The undertaking consisted of site inspection/monitoring along Aroma Beach and interview with the concerned local government units. Status/updates are reported on the table below.

During the inspection, beach sand extraction activities were not observed.</p> <p>The team then proceeded to the San Roque Barangay Hall, where Kagawad Joselito Dinglasan stated that the barangay has not received any related reports/complaints/information about beach sand extraction since the complaint was lodged. He also informed that the Barangay Tanods conduct roving and monitoring at Aroma Beach on a regular basis and have not reported any incidents of such activity. Attached here is the barangay Certification stating the same which was issued on October 28, 2022.</p> <p>A meeting with Mr. Padilla has also been scheduled through the barangay officials in Poblacion 3, where Mr. Padilla is currently residing. However, they were not able to locate Mr. Padilla.</p>


### **C E R T I F I C A T I O N**

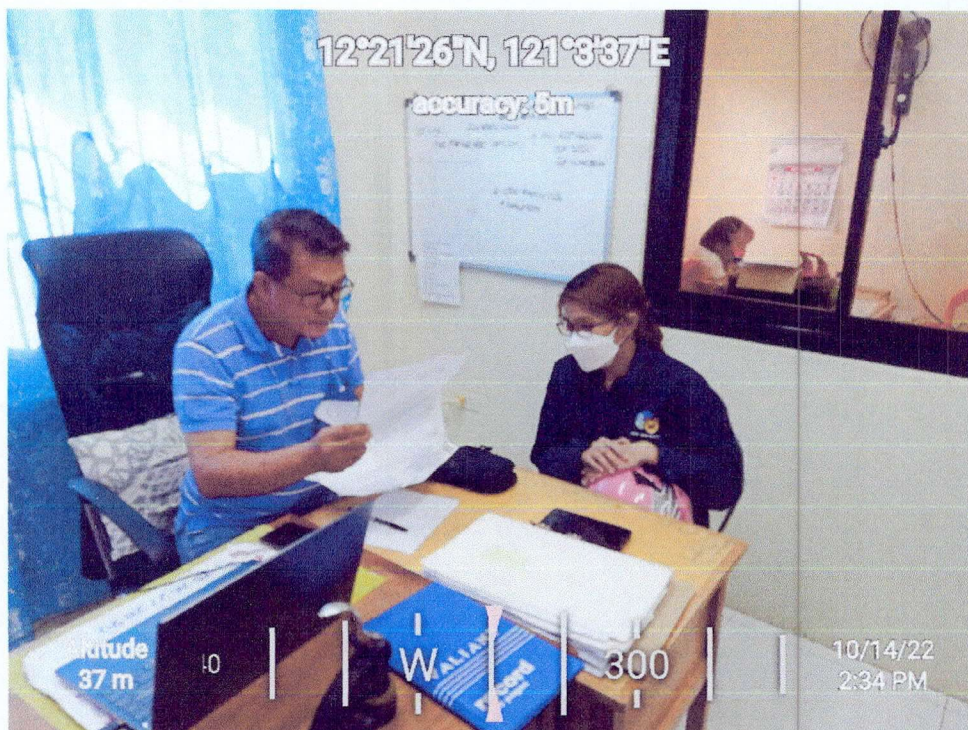
