Tenolite and Reynaldo T. Conda conducted the follow-up operation within the vicinities of Barangay Alacalian, and Banbanan, Taytay, Palawan for the possible recovery of the stolen boat owned by Mr. Andres Sta. Ana of Sitio Pinagpala, Barangay Alacaian, Taytay, Palawan.

During the operation, the team observed some men in Sitio Pinagpala, Barangay Alacalian that seemed to be waiting for them regarding the stolen boat, because of this, we immediately left the said area and continued to search in the other part of Malampaya Sound where possibly the said boat could be hidden or placed. Unfortunately, after searching the area and asked for some information in nearby barangays, no one could give information. The team returned to PAMO-MSPLS and plan to conduct another patrol and monitoring to gather more information about the incident.

This pertain to the above mentioned subject. On October 13, 2022 at around 2:40 in the morning, unidentified three (3) men one (1) man wearing green long sleeves with printed name of DOLE Tupad and two (2) men without shirt which covered their faces by putting on color red shirt so as not to be recognized and stolen the apprehended boat owned by Mr. Andres Sta. Ana of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan with bearing name "Jericho and Rjay" that properly docked and hanged with ties/ropes near the kitchen of Protected Area Management Office (PAMO) of MSPLS, Barangay Old Guinlo, Taytay, Palawan.

At around 2:45 in the morning of the same date, the undersigned with Admin. Assistant Melky P. Oab saw that the boat owned by Mr. Sta. Ana was taken near the pier of this Office and it is currently towed by a one (1) motorized boat whose color is "light blue with black lining/liston" but did not see its name which used by the unidentified three (3) culprits. Further, man wearing green long sleeves was seen by the undersigned with a flashlight pulling the said boat into the deep portion of the sea near the pier of PAMO because it is currently low tide at the moment, and helped by his two (2) companions in tying to the boat they used to pull it completely. Likewise, an approximately 30-40 meters away from the pier the engine would not start did not function and the boat stolen was accidentally released which the undersigned immediately took action by jumping into the water trying to recover it but the culprits managed to get it again and one culprit shout loudly "pre magpaputok ka ng baril" luckily there is no gun shot and they escaped hurriedly. Meanwhile at around 2:53 in the morning, PASu Clarissa P. Pador also witnessed the taking and pulling of the apprehended boat. Be informed also that the undersigned is the assigned personnel to manned this Office together with Admin. Assistant Oab and PASu Pador because there is a separate activity in Barangay Liminangcong that other staff will have to stay overnight. We exert our effort to stop the towing but also fear of life since they shout loudly "pre magpaputok ka ng baril".

Further, this incident is possibly related to the apprehension of the one (1) motorized boat and one (1) set of trawl net with board owned and operated by Mr. Rodel Angeles Estrella of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan on September 29, 2022 that is reported through memorandum on September 30, 2022 in your Office and PENR Office of Palawan.

In this regard, the undersigned with PASu Pador is hereby recommends that immediate protection be provided by appointing a Security Guard in this Office to prevent this kind of incident since it has not only happened once and some of the PAMO-MSPLS Rangers have received death threats.

**FACTS** 

At about 3:40 PM of October 13, 2022 Mr. Erwin Carlos Balvin, DENR Employee personally appeared to this office and reported the above incident. Initial investigation conducted disclosed that on above date, time and place of incident, it was revealed that while on his night shift duty, the reporting person seen the three (3) unidentified individuals on their act of stealing one (1) motorized banca with description white and red color painted body with writings "Jerico and RJay" previously owned and registered to Mr. Andres Sta. Ana which was under the custody of the MSPLS-DENR-CENRO-Taytay for alleged violation of RA 11038. Upon seeing the incident, Mr. Balvin immediately shouted at the three individuals to stop them but they continue their unlawful acts which prompted Mr. Balvin to chase them but he stopped when he heared one of them telling his companion "putukan mo na!". He hid for the fear that said individuals might be armed until they fled away. According to the herein reportee, he cannot recognize said individuals due to darkness and their heads were wrapped with t-shirts.
