

Please be informed that the undersigned assisted in the collection of water samples in the ten (10) El Nido Bay Stations and three (3) Estero Stations within El Nido-Taytay Managed Resource Protected Area (ENTMRPA) spearheaded by the Provincial Environmental Management Unit (PEMU) personnel Mr. Peter Abobot and Ms. Rio M. Reyes on October 5, 2022 under target activity on Water Quality Monitoring within Legislated NIPAS Protected Area Under Marine Protected Area Strengthening And Networking of El Nido-Taytay Managed Resource Protected Area (ENTMRPA) for Month of Ocotber 2022.

The team collected the water samples from the established ten (10) sampling sites in the identified El Nido Bay Stations particularly in Twin beach, Nacpan port, Nacpan beach, Calitang beach, Peaceful/Lamoro beach, Lio beach, Lio port, Lio runway, Sitio Caalan and Caalan beach as well as in the three (3) Estero Stations particularly in So. Cabigsing, Brgy. Buena Suerte and Brgy. Maligaya. Water quality checker such as HORIBA U-53G was used to initially determine the primary water parameters such as temperature, dissolved oxygen, pH, conductivity, ORP and turbidity. The water samples were sent to the EMB Regional Office for further laboratory analysis.

Please be informed also that this office already requested the laboratory results/analyses of the conducted water samplings from January 2022 to October 2022 as well as the results of the same activity that will be conducted on November 2022 and December 2022.
