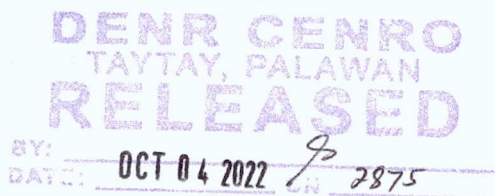

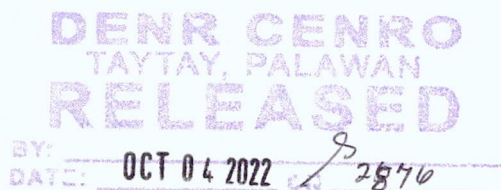
Greetings!

Respectfully submitting is the report of the undersigned pertaining to the above subject conducted on September 13, 2022.

Please be informed that the CBFM-CARP 2018 project entitled "Forest and Fruit Trees with Bamboo Plantation Project" was awarded to the People's Organization of Bato Multi-Purpose Cooperative (BMPC) with the total area of 25 hectares that consist of various commodities such as Bamboo, Gmelina, Durian, Rambutan Cacao, Calamansi, Guyabano, Dragon fruits, Banana intercropped with pineapple and vegetable crops.

The undersigned, together with the members of the BMPC was conducted the aforementioned monitoring and during the activity, the following were observed, to wit:

- Some of the affected commodities by the summer season and installation of NAPOCOR's steel post had not yet replaced;
- There are some unmaintained plantations

In view of above observations, the following are recommended;

- Conduct clearing on the planted commodities;
- Conduct stripping and replanting the affected commodities;
- The PO should follow up the NAPOCOR on their demand for the replacement of the affected commodities by the stalled steel post.

Further, the PO has decided to locate the area as a replacement to the portion affected by NAPOCOR in order to maintain the plantation of their CARP project. Moreover, they advised that the area should be surveyed and likewise have to submit the resolution for the said relocation site for the approval of the Regional Office.

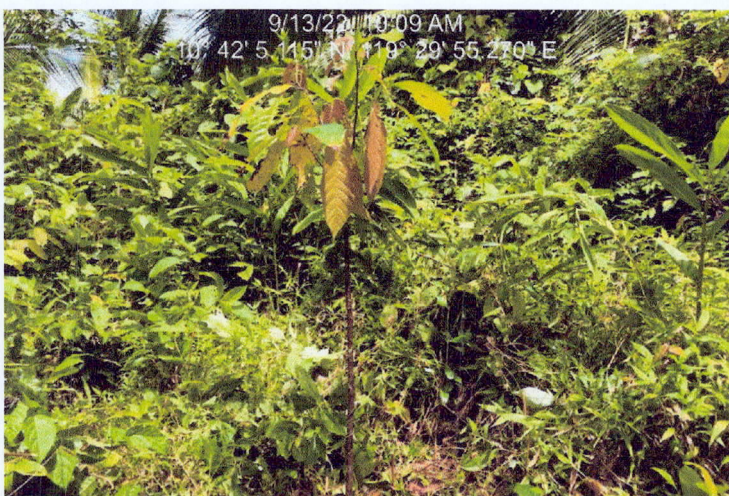
