Thus, in the meantime, as what the DENR, under former Secretary Cimatú did in BORACAY, AKLAN, **we pray that DENR issue a CEASE AND DESIST ORDER**, for LGU implementation, **TO STOP the continued operations, development and expansion** of said Nonok Beach Resort by Atty. Benedicto, Jr. and family.

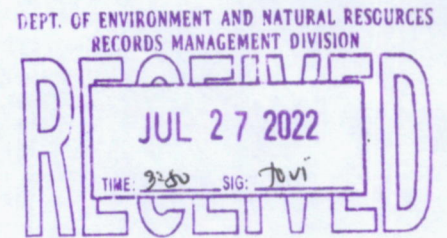

Benedicto, Jr. My daughter FE Diana and I have been subjected to **multiple criminal harassment cases** by Atty. Francisco F. Benedicto, Jr and his lawyer son, Atty. Francisco S. Benedicto, III.


