Respectfully submitting is the report of the undersigned pertaining to the above subject conducted on August 30 – September 1, 2022.

Please be informed that the CBFM-CARP 2018 project entitled "Fuel Wood with Orchard Plantation" was awarded to the People's Organization of San Fernando Agro-Forestry Producers Cooperative (SFAFPC) with the total area of 100 hectares that consist of various commodities such as Ipil-ipil, Kakawati, Gmelina, Bamboo, Calamansi, Cacao, Coffee, Rambutan, Guyabano, Dragon fruit, Banana intercropped with Pineapple, Cassava and vegetable crops.

During monitoring, the undersigned, together with FT II Zion S. Sunit, OIC-Chief, CBFM Unit, conducted a meeting in the morning of August 30, 2022 to the beneficiaries of the said project held at the covered court of Barangay San Fernando, El Nido, Palawan to tackle previous issues and concerns with their respective plantations such as high mortality rate of their planted commodities and unmaintained areas. It was stressed during meeting that the beneficiaries should have to maintain their plantation and should replace the affected commodities because the said project has been granted for their own benefit. Further, they are likewise reminded the importance of having the said project. Afterwards, the beneficiaries agreed that they will start the clearing of their plantation and conduct as well the stripping and replanting of the affected commodities on September to October of this year. They again reminded that this Office will be conducting another monitoring to check their committed activities and shall be reported for the last quarter of CY 2022.

In the afternoon of August 30 to September 1, 2022, the monitoring was conducted and yet, the same observations of the abovementioned issues and concerns were still noted. Therefore, the undersign recommends that the beneficiaries should conduct a massive replanting and clearing of their respective plantations.


