For resolution is the complaint for Violation of P.D. No. 705 filed by CENRO Leonard T. Caluya against respondents Jay-ar Doctor and Erwin Buntired for allegedly conspiring and/or mutually helping one another in possessing and/or transporting forest products consisting of "apitong baboi" lumber with an estimated market value of two Thousand Nine Hundred Twenty Five Pesos (P2,925) and estimated total damages of Thirty Three Thousand Six Hundred Nineteen Pesos and Forty Centavos (P33,619.40) without necessary license or permit from the appropriate government agency/authority last September 3, 2020 in Sitio Balete, Barangay Punta Baja, Rizal, Palawan.

Submitted as evidence to support the instant complaint are the following:

- 1. Malayang Sinumpaang Salaysay of Armando J. Batayo;
- 2. Malayang Sinumpaang Salaysay of Jay O. Abdulgapar;
- 3. CENRO Memorandum Re: Apprehension of Three Units of Motorcycle with Sidecar (locally known as "topdown") Loaded with Undocumented Lumber of "apitong baboi" having a total volume of 397 board feet in Sitio Balite, Barangay Punta Baja, Rizal, Palawan;

- 4. Seizure Order issued by Ma. Teresa Ayson of DENR-CENRO;
- 5. Seizure Receipt No. CENRO-QZN-SR-2020-10-0020;
- 6. Tally Sheet of the confiscated "apitong baboi" specie executed by Armando J. Batayo of DENR-CENRO;
- 7. Statement of Damages issued by Kathleen Khye Mozo, Forester 1 of DENR-CENRO;
- 8. Apprehension Receipt issued by Jay Abdulgapar and Armando Batayo;
- 9. Certification issued by Mercy A. Santos, Forest Technician II of DENR-CENRO dated August 13, 2021 attesting that no clearance or permit was issued to Mr. Allan Hasigan, Mr. Janilo Culis, Mr. Randy Burogod, Mr. Jay-ar Doctor and Mr. Erwin Buntired to cut/gather/possess/transport "apitong baboi" specie in Palawan;
- 10. Certification issued by David Gallema, Jr. dated October 14, 2020 attesting that the apprehended three (3) units of motorcycle with sidecar ("topdown")were in the custody of DENR-CENRO Quezon, Rizal Station, Rizal, Palawan; and
- 11. Pictures allegedly showing the marking and inventory of the confiscated evidence.

Records show that Forest Technicians Armando Batayo and Jay Abdulgapar, employees of DENR-CENRO, Quezon were conducting a patrol and surveillance operation in Sitio Balete, Barangay Punta Baja, Rizal, Palawan at about 9:30 in the evening of September 3, 2020; that in the course thereof, they chanced upon respondents on board a top-down tricycle carrying species of unidentified lumber; that when asked to produce license/permit, they failed to produce any necessary document from the appropriate government authority hence their arrest; that Abdulgapar conducted the marking and inventory of the confiscated items in the DENR-CENRO Office in Rizal, Palawan in the presence of respondents; that thereafter, Batayo and Abdulgapar conducted a scaling of the confiscated lumber which they identified as "apitong baboi" species and that Mercy A. Santos, Forest Technician II of DENR-CENRO issued a Certification attesting clearance/permit issued was respondents to

cut/gather/possess/transport the said "apitong baboi" species in Palawan.

Subpoena was issued requiring respondents to submit their Counter-Affidavit and other controverting evidence for their defense. To date however none was submitted.

We now rule.

On the basis of the evidence submitted the undersigned finds probable cause that the offense under Section 77 of Presidential Decree No. 705 as amended by Executive Order No. 277 and RA 7161 was committed and that respondents are probably guilty thereof hence should be held for trial.

We find that respondents Doctor and Buntired were, at the very least, in constructive possession of the timber without the requisite legal documents. Respondents, who were helping each other, were found in the top-down tricycle loaded with 14 pieces of "apitong baboi species". The uncontroverted evidence sufficiently established that respondent Doctor was the driver of the vehicle and he was accompanied by his co-respondent Buntired. It is presumed that they exercised full control of the vehicle that they were driving and/or using and that they knew what its load was.

Mere possession of timber or other forest products without the proper legal documents, even absent malice or criminal intent, is illegal. In this case, it was sufficiently established that their possession of lumber was made without any license or permit issued by any competent authority.
