Respectfully forwarded is the memorandum of CENRO Coron, Palawan dated October 05, 2022 relative the above subject.

Per memorandum, the apprehension was made on June 15, 2022 at around 10:06 A.M. by the Enforcement Personnel of CENRO Coron after the confirmation of report that was first received on June 14, 2022 that there are stockpiled of lumbers covered with corrugated sheets in Sitio Dimagyare. The team immediately coordinated to the Barangay Officials of Decabobo and accompanied the team to verify the said report. Thereafter, the team apprehended the eleven (11) pieces of assorted sizes of lumbers of Ipil species with total volume of 115.99 board feet at Sitio Dimagyare, Barangay Decabobo, Coron, Palawan.

The apprehended lumbers with fair market value of Php9,279.20 is now deposited at CENR Office for safekeeping purposes under the custody of Quick Response Team. The alleged perpetrators are Ms. Rodalyn C. Magallanes and Mr. Jed Amit wherein the former revealed that Mr. Amit is the one who stockpiled the said lumbers in the area.

The administrative hearings were conducted on June 28, 2022 & August 12, 2022 and the notices of hearings particularly on June 16, 2022, June 23, 2022 and June 30, 2022 were sent to the concerned parties in relation to Section 7 of DAO 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order and filing of appropriate charges before the proper court.

Respectfully submitted is the Administrative hearing report and other pertinent documents on the apprehended eleven (11) pieces lumber (Ipil species) with a total volume of 115.99 bd. ft. at So. Dimagyare, Brgy. Decabobo, Coron, Palawan on June 15, 2022.


During the conduct of Administrative hearing on June 28, 2022, Forester II Emma C. Francisco, Team Leader of the apprehending officers narrated that on June 14, 2022, a concerned citizen called her and reported the stockpiled lumber in So. Dimagyare in Brgy. Decabobo. She called Forest Technician Darius Jagmis and Forest Ranger Harlan Ilovino, but they are not answering their phones because they are practicing basketball in Brgy. 6. The following day, the concerned citizen called her again, so they proceeded to Brgy. Decabobo. They first coordinated to the Barangay and reported the alleged stockpiled lumbers. Some Barangay Officials led by the Officer In-Charge, Barangay Kagawad William Balbutan accompanied the team to verify the alleged report. Indeed, lumber were stockpiled in the said area. The claimant of the area, Ms. Rodalyn C. Magallanes said that Mr. Jed Amit asked her permission to temporary placed said lumbers in her claimed area. However, Mr. Jed Amit denied the allegation during the hearing.

On August 12, 2022, another hearing was scheduled since Ms. Rodalyn C. Magallanes was not able to attend the Administrative hearing on June 28, 2022. Forester Emma C. Francisco repeated her narration. The undersigned asked Ms. Magallanes if it is true that Mr. Jed Amit is the one who stockpiled said lumber. She pinpointed Mr. Jed Amit that he is the one who placed those said lumbers in the particular area. Mr. Amit admitted but according to him, he is not the owner.

The said apprehended items are now hauled and deposited at CENR Office for safekeeping purposes.

Due to the above information, the undersigned hereby recommends for the issuance of "ORDER OF CONFISCATION" in favor of the government pursuant to DAO 97-32 and other applicable laws, rules and regulation and to file criminal case against the offender Mr. Jed Amit for violation of PD 705, Section 777 as amended.
