Respectfully forwarded is the memorandum of CENRO Brooke's Point, Palawan dated October 17, 2022 relative the above subject.

Per memorandum, the apprehension was made on January 25, 2022 at around 12:00 P.M. during the Law Enforcement Operation conducted by the elements of 2<sup>nd</sup> SOU, PNP-MG Balabac SBU/Rio Tuba Detachment concerning the alleged violation of Section 77 of PD 705 at So. Tagpisa, Barangay Ocayan, Bataraza, Palawan.


The team intercepted/apprehended the one (1) unit 070 STIHL Chainsaw with Serial Number R050463793 and detached Metal Seal while being used in the actual sawing/slicing of a freshly cut Mango tree (Two (2) pieces of Mango flitches-196 board feet) without pertinent documents from the Palawan Council for Sustainable Development (PCSD) and DENR. The estimated fair market value of the Chainsaw is Php30,000.00 while the Mango flitches is Php8,428.00.

The said apprehended items were recovered in the possession and control of Mr. Rojelio B. Sanidad (Operator) and Mr. Marvin V. De Pedro (Owner of the Mango tree/flitches and helper), both residents of Rio Tuba, Bataraza, Palawan. The apprehended 2 pieces Mango flitches are temporarily stockpiled at Barangay Ocayan, under the custody of Punong Barangay Danilo S. Recla for safekeeping purposes while the apprehended chainsaw had been properly turned-over to PCSDS. Further, the damaged Mango tree where the flitches came from, may cause imminent danger to human considering that it is beside to the house of Mr. De Pedro and have fallen branches from the tree.

Notices of hearing dated February 28, 2022, March 01, 2022 and March 14, 2022 were sent to all concerned parties and the administrative hearing was conducted on March 25, 2022 at the Office of CENRO Brooke's Point, M. Rodriguez St. Poblacion District I, Brooke's Point, Palawan in relation to Item No. 1 & 2, Section 7 of DAO 1997-32.

We concur with CENRO recommendation that the matter be referred to PCSD relative to the violation of RA 9175 for their further investigation/adjudication and filing of appropriate case against the above-mentioned offender.

Submitted herewith is the minutes of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32. The hearing was conducted on March 25, 2022 at CENRO Brooke's Point, Palawan.

**I. FACTS OF THE CASE**

The apprehension was made during the Law Enforcement Operation conducted by elements of 2<sup>nd</sup> SOU, PNP-MG Balabac SBU/ Rio Tuba Detachment on January 25, 2022 at Sitio Tagpisa, Barangay Ocayan, Bataraza, Palawan.

The one (1) unit chainsaw – 070 STIHL Chainsaw with Serial Number R050463793 and detached metal seal had been intercepted/apprehended while being used in the actual sawing/slicing of a freshly cut mango tree (mango flitches) without pertinent documents from the DENR. Meanwhile, during on-site investigation, it was mentioned that the chainsaw used in the slicing/sawing activity is covered by a Certificate of Registration issued by the PCSD however said COR is in the possession of the alleged owner of chainsaw – Mr. Henry B. Contreras. Per verification however, the apprehended chainsaw did not match with the description of the registered chainsaw of Mr. Contreras as indicated in the COR he had presented. The apprehended items (1 unit chainsaw and 2 pieces mango flitches) were recovered in the possession and control of Mr. Rojelio Sanidad (operator) and Mr. Marvin De Pedro (owner of mango tree/flitches and helper), both residents of Barangay Rio Tuba, Bataraza, Palawan. Presently, the apprehended two (2) pieces mango flitches are temporarily stockpiled at Barangay Ocayan under the custody of Punong Barangay Danilo S. Recla for safekeeping purposes while the apprehended chainsaw had been properly turned-over to PCSDS.

## II. STATEMENTS OF PARTIES INVOLVED DURING THE HEARING PROCESS

During the hearing on March 25, 2022, the Hearing Officer read the affidavit submitted by Patrolman Larry Garcia, Jr. of 2<sup>nd</sup> SOU MG Rio Tuba Detachment in which the latter testified that in response to the information that their station had received from a reliable informant concerning the alleged illegal cutting of trees using chainsaw at Sitio Tagpisa, Barangay Ocayan, Bataraza, Palawan, PEMS Richard P. Rodriguez, PNCOIC of 2<sup>nd</sup> SOU MG Balabac SBU/ Rio Tuba Detachment immediately organized and dispatched a team composed of Patrolman Garcia, Patrolman L'vern C. Garzon, PSSg Edcel G. Inoferio and PMSg Rudy C. Azares (Team Leader) to conduct an operation in the area. While approaching the subject area, at more or less 12:30 in the afternoon (12:30 PM), the team right away heard loud sounds which they believe were from a chainsaw being operated. The team then proceeded to the location where the sound was coming from which resulted to the discovery of two (2) individuals caught in the act of slicing of freshly cut mango tree with the aid of a chainsaw.

During on-site investigation, PMSg Azares verified from the chainsaw operator later identified as Mr. Rojelio Bostria Sanidad and Mr. Marvin Villano De Pedro (helper) if the cutting of the mango tree and the chainsaw used therein were covered by pertinent documents/registration from concerned agencies particularly the DENR and PCSD in which Mr. Sanidad claimed that the documents were left at the house of the owner of the chainsaw - Mr. Henry Baladjay Contreras, a resident of Barangay Rio Tuba.

The apprehended items and persons were then brought at 2<sup>nd</sup> SOU-MG Rio Tuba Detachment Station in Sitio Marabahay, Barangay Rio Tuba, Bataraza, Palawan for further investigation and documentations. PMSg Rudy Azares also submitted an affidavit with contents same/corroborated with the statements of Patrolman Larry Garcia, Jr.

*Note: That the apprehending officers also arrived although their submitted affidavit had been read. Moreover, all respondents affirmed to voluntary give their statements without the presence of their lawyer or legal counsel.*

In the same hearing, Mr. Rojelio B. Sanidad recounted that on January 25, 2022 at more or less 12:00 noon, he and Mr. Marvin De Pedro (owner of mango tree/flitches and helper) were caught in the act of sawing/slicing up a mango tree. Mr. Sanidad claimed that subject mango tree was already cut down by an axe and that out of pity; he agreed to help saw/sliced it up which will then be used for the construction of Mr. De Pedro's house for an agreed payment of ₱12.00 per board feet. According to Mr. Sanidad, Mr. De Pedro had told him that he has a Barangay Certification to support the sawing/slicing of the mango tree however Mr. Sanidad admitted that aside from the said Barangay Certification which Mr. De Pedro had left at home there were no permit/s from the DENR or other concerned government agency. Mr. Sanidad then disclosed that he is the owner of the apprehended chainsaw however he does not have any documents as proof of ownership. Mr. Sanidad also claimed that it was because he was caught off-guard and got scared thus he pinpointed Mr. Henry Contreras as the chainsaw owner during the apprehension. Mr. Sanidad explained that Mr. Contreras owned a registered chainsaw which Mr. Sanidad is likewise the operator. Said registered chainsaw is intended for the slicing of coco lumber at the lumberyard of Mr. Contreras in Barangay Rio Tuba. Mr. Sanidad further admitted that he knew that the illegal possession of a chainsaw unit is against the law however he remarked that his chainsaw is only for personal use and not for illegal activities. Similarly, he is aware that the sawing/slicing of any lumber/tree species must be covered by appropriate documents/permit.

Also in the same hearing, Mr. Marvin V. De Pedro affirmed that he and Mr. Rojelio B. Sanidad are the individuals caught in the act of sawing/slicing up a mango tree/flitches without permit/s on January 25, 2022. Mr. De Pedro admitted that he is the owner of the mango tree/flitches situated within their lot allegedly covered by a Deed of Sale per his response when asked if the lot is covered by a title. Mr. De Pedro explained that the subject mango tree is located beside their house which was then damaged by fallen branches from the tree. Consequently, he decided to have the mango tree cut off intended for the construction/repair of

the damaged house. Mr. De Pedro then commissioned Mr. Sanidad to saw/slice the tree for ₱12.00 per board feet. Mr. De Pedro admitted that the cutting and slicing of the mango tree is not cover by permit and refuted Mr. Sanidad's statement that he has a Barangay Certification. As for the chainsaw, Mr. De Pedro added that he thought that Mr. Sanidad will be using the registered chainsaw of his uncle Henry Contreras. Moreover, Mr. De Pedro claimed that he does not know that there is also permit to be secured for cutting of mango tree.

Also in the hearing, Mr. Henry Contreras strongly denied the allegations against him being the owner of the apprehended chainsaw as well as any participation/involvement nor knowledge about the transaction re: the illegal cutting and slicing of the subject mango tree through the aid of a chainsaw. On the other hand, Mr. Contreras admitted that he has a registered chainsaw and presented its corresponding Certificate of Registration issued by the Palawan Council for Sustainable Development (PCSD) for verification. In addition, Mr. Contreras stated that he knew that permit/s is/are needed for the cutting/slicing of wood or anything wherein the chainsaw will be used. Mr. Contreras disclosed that he uses his chainsaw on slicing of lumber sold to him on some occasion and clarified that said chainsaw is not being used for the cutting of wood/trees other than coconut trees which his license covers or is intended for (*Coco Lumber Trading*). Mr. Contreras added that he always secures the needed/required cutting and transport permits from PCA.

Mr. Julius Salazar also attended the hearing to prove/support that Mr. Henry Contreras is not present at the site of apprehension and that Mr. Contreras is at home when the apprehension took place. Mr. Salazar mentioned that the hollow block machine/mixer he was working with is in front of Mr. Contreras' house wherein Mr. Salazar likewise resides. Mr. Salazar added that he only learnt about the apprehension when the police together with the chainsaw operator arrived at Mr. Contreras' residence and asked for permit.

PMSg Rudy C. Azares clarified that when Mr. Rojelio Sanidad said that he has a Certificate of Registration of Chainsaw which is in the possession of Mr. Henry Contreras (*alleged owner of the apprehended chainsaw*), Mr. Azares' team went to the house/residence of Mr. Henry Contreras for validation. Accordingly, based from the claim of Mr. Sanidad, PMSg Azares only asked for the copy of the COR which Mr. Contreras personally presented. Upon scrutiny/review of the document, the description of the chainsaw in the COR did not match with the apprehended chainsaw with detached metal seal which they also explained to Mr. Contreras. PMSg Azares mentioned that they did not see the other chainsaw. PMSg Azares then remarked that during that time, Mr. Contreras should have denied that he is the owner of the chainsaw and shouldn't have given them copy of the COR. PMSg Azares added that they decided to include Mr. Contreras in the case as he and Mr. Sanidad were pinpointing at each other and that it seems like Mr. Contreras was covering up for the operator (Mr. Sanidad) who also works for him. Patrolman Larry P. Garcia, Jr. one of the apprehending officers also concurred with his Team Leader, PMSg Azares's statements.

Mr. Henry Contreras on the other hand, explained that PMSg Azares only inquired if he has a registered chainsaw thus he presented the COR; however, PMSg Azares did not mention that they had apprehended the chainsaw owned by Mr. Sanidad. Mr. Contreras added that his registered chainsaw is also in his house. Meanwhile, Mr. Contreras also mentioned that the PNP Maritime had told him that they had apprehended a chainsaw thus he stated that the chainsaw he owned is registered and presented the corresponding COR as proof that his registered chainsaw differs from the apprehended chainsaw which Mr. Sanidad was saying was his. Mr. Contreras stated that he also mentioned/explained the situation to the apprehending team particularly when they asked him for a copy of SUP as he did not secure one for he is not involved in the subject transaction.

In response, Patrolman Garcia clarified that when they went to Mr. Contreras residence, Mr. Sanidad himself pinpointed Mr. Contreras as the chainsaw owner thus when Mr. Contreras showed the COR they are all together. PMSg Azares added that Mr. Sanidad clearly stated that

the COR of the chainsaw was left at home thus they decided to go over Mr. Contreras' residence for verification. Mr. Sanidad then pinpointed Mr. Contreras and the latter presented the COR.

### III. FINDINGS/EVALUATION

The cutting/sawing/slicing of the mango tree and the possession of wood products (mango flitches) are not covered by appropriate DENR documents/permits; hence, a patent violation of Section 77 of PD 705 as further amended. Moreover, the chainsaw used is likewise not covered by appropriate documents/permits issued by the PCSD which is a violation of RA 9175 or Chainsaw Act of 2002.

In view of the facts presented, it was found out that there were sufficient and convincing evidences to support the finding of probable cause to charge **MR. ROJELIO B. SANIDAD** and **MR. MARVIN V. DE PEDRO** of violation of RA 9175 and Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

In contrast, due to insufficient evidences, probable cause to charge the alleged owner of chainsaw - **MR. HENRY B. CONTRERAS** cannot be established.

### IV. RECOMMENDATION


In view of the above findings and evaluation of the evidences on hand, it is recommended that appropriate charges be filed against the above – mentioned offenders for violation of Section 77 of PD 705 as further amended by E.O. 277 and R.A. 7161.

In addition, it is also recommended that the matter be referred to PCSD relative to the violation of RA 9175 for their further investigation/adjudication and filing of case against the above-mentioned offenders.

**Hearing Officer:** Magandang umaga po sa inyo, pinatawag namin ngayong umaga itong pagdinig ng dahil sa nakumpiskang Isang (1) yunit ng chainsaw Stihl 070 na may serial number 50463793 at dalawang (2) kahoy o tablon na manga sa isinagawang operasyon ng 2<sup>nd</sup> SOU – MG Rio Tuba Detachment noong Enero 26, 2022 sa Sitio Tagpisa, Barangay Ocayan, Bataraza, Palawan. Ayon po dito sa mga report na isinumite ng PNP Maritime Group ang nabanggit na mga tao na sinasabing nahuli sa akto sa pagtitistis na nabanggit na kahoy ay sina Rogelio Bostria Sanidad, 55 years old, Marvin Villano De Pedro, 32 years old na pawang nakatira sa Barangay Rio Tuba, Bataraza, Palawan at ang nababanggit dito na nagmamay-ari ng chainsaw ay si Ginoong Henry Contreras. Bago po natin ipagpatuloy yung usapin o pagdinig ngayong umaga, gusto ko lang ipabatid sa inyo na ayon po sa ating bagong saligang batas, kayo po ay may karapatan na kumuha ng inyong sariling abogado o legal counsel na maaari niyong dalhin dito para kayo ay alalayan na sumagot sa aking magiging katanungan sa inyo mamaya kaya kung sabihin niyo na kailangan niyo ng abogado, ipagpapaliban natin ngayon at bibigyan ko kayo ng pagkakataon na humanap ng inyong sariling abogado at i-resschedule natin yung pag-uusap. **Hearing Officer:** Si Mr. Marvin De Pedre, kailangan mo pa ba ng abogado?

**Marvin V. De Pedro:** Hindi na po.

**Hearing Officer:** Kayo po Mr. Henry Contreras, kailangan niyo pa ba ng abogado?

**Henry B. Contreras:** Sa ngayon po hindi na po.

**Hearing Officer:** Ituloy natin ang pag-uusap, bagamat ang apprehending team ay pinadalhan namin ng imbetasyon ngayong umaga pero hindi sila nakadalo, pero nakapagsumite na po sila ng kanilang affidavit at babasahin ko sa inyo para marinig ninyo ang nilalaman po nito. (Reading of Affidavit of Patrolman Larry Garcia Jr.) at mayroon pa din poi sang salaysay dito ni PMSg Rudy Azares na kung babasahin ay halos pareho din yung nilalaman ng kanilang statement. Nandito na po kararating lang yung mga apprehending team ang PNP – Maritime Group, kay PMSg Rudy Azares at kay Patrolman Larry Garcia Jr., mayroon pa po ba kayong idagdag sa mga statement ninyo?

**PMSg Rudy C. Azares:** Wala na po.

**Hearing Officer:** Kayo po Patrolman Larry Garcia, mayroon pa po ba kayong idagdag?

**Pat Larry P. Garcia Jr.:** Wala na rin po.

**Hearing Officer:** Ang uunahin kop o ay si Mr. Rojelio B. Sanidad, for record purposes pakibanggit ang iyong buong pangalan, edad, trabaho, saan nakatira at iba pang bagay na maaaring pagkakilanlan sa iyong pagkatao.

**Rogelio B. Sanidad:** Ako po si Rojelio B. Sanidad Bostia, nakatira sa Barangay Rio Tuba, Bataraza, Palawan, 67 taong gulang.

**Hearing Officer:** Kailan kayo ipinanganak?

**Rogelio B. Sanidad:** 1959 po siguro hindi ko na po matandaan.

**Hearing Officer:** Anong trabaho po?

**Rogelio B. Sanidad:** Ang trabaho kop o ay nag-titistis lang ng coco lumber.

**Hearing Officer:** Naalala po ba ninyo kung saan kayo ng humigit kumulang alas dose ng tanghali noong January 25, 2022?

**Rogelio B. Sanidad:** Yun na po yung pagkahuli namin noong araw na yun.

**Hearing Officer:** Bakit po kayo hinuli?

**Rojelio B. Sanidad:** Dahil po doon sa pinutol na tinumba na po kasi ng palakol yung manga na yun, nakiusap po kasi sa akin yung tao na kung puwede tayuan nila ng bahay, kung puwede pakitistis po daw kasi sayang din gagamitin din daw nila sa bahay nila yun po ang pagkasabi sa akin naawa po ako kaya tinistis ko po, para sabi ko makatulong din ako kaya doon na po kami nahuli. Pero pinutol na po ng palakol yun.

**Hearing Officer:** Sino ang may-ari na binabanggit ninyo ng kahoy na yun?

**Rojelio B. Sanidad:** Si Marvin De Pedro po.

**Hearing Officer:** Ano po ang naging usapan ninyo doon sa pagputol ng kahoy o pagtistis?

**Rojelio B. Sanidad:** Ang sabi niya po sa akin pakitistis ko lang daw kasi patayuan nga nila ng bahay. Tinumba na rin yan ng palakol bago ko pinuntahan yun po ang usapan namin doon.

**Hearing Officer:** Magkano po yung serbisyo o yung pagtistis ng kahoy na babayaran sa inyo?

**Rojelio B. Sanidad:** Ang usapan namin po dose and board feet.

**Hearing Officer:** Tinanong o hinanapan ninyo ba siya ng permit yung kahoy na tinistis niyo?

**Rojelio B. Sanidad:** Sinabihan kop o siya ang sabi niya mayroon daw po siya sa barangay.

**Hearing Officer:** Ipinakita ba niya sa inyo yung permit o certification ng Barangay?

**Rojelio B. Sanidad:** Hindi na po basta sabi niya naiwan sa bahay nila.

**Hearing Officer:** Sino po ang kasama ninyo na nagtistis ng kahoy?

**Rojelio B. Sanidad:** Kami rin dalawa din po ni Marvin, siya na rin po ang nag-helper.

**Hearing Officer:** Bukod kay Marvin De Pedro sino pa bang ibang kasama ninyo doon?

**Rojelio B. Sanidad:** Dalawa lang po kami.

**Hearing Officer:** Ibig sabihin noong hinuli o nadatnan po kayo ng PNP Maritime, dalawa lang kayo ni Mr. Marvin De Pedro?

**Rojelio B. Sanidad:** Opo, bago nagdatingan yung mga tao nandoon na sila.
